### ORDER:

The following notification will be published in the Tamil Nadu Government Gazette:-

### NOTIFICATION

In exercise of the powers conferred by section 19 of the Tamil Nadu Fishermen and Labourers engaged in Fishing and other Allied Activities (Social Security and Welfare) Act, 2007 (Tamil Nadu Act 19 of 2007), the Governor of Tamil Nadu hereby makes the following amendment to the Schedule to the said Act.

### AMEDMENTS

In the said schedule,-

(1) Under the heading "Accident Relief" in column (2),-

- (i) for the figure "1,00,000" in column (3) against the entry "(a) Death due to accident" in column (2), the figure "2,00,000" shall be substituted.

- (ii) for the figure "50,000" in column (3) against the entry "(f) Loss of one hand or one leg" in column (2), the figure "1,00,000" shall be substituted.
- (iii) for the figure "20,000" in column (3) against the entry "(g) Loss of limbs from grievous injuries other than those specified above" in column (2) , the figure "50,000" shall be substituted.
- (2) for the figure "1,00,000" in column (3) against the entry "Death while fishing or Immediately thereafter not due to Accident" in column (2), the figure "2,00,000" shall be substituted.
- (3) for the figure "1,00,000" in column (3) against the entry "Missing fisherman while fishing" in column (2), the figure "2,00,000" shall be substituted.
