ORDER:

The Hon'ble Chief Minister has made announcement that 300 MT of Milk Powder and 15000 litre Ultra Heat Treatment Milk will be supplied to Kerala State towards flood relief and Additional Chief Secretary/ Commissioner of Revenue Administration was nominated as Nodal Officer to coordinate the supply of relief materials.

- 2. In the letter second read above, the Managing Director, Tamil Nadu Co-operative Milk Producers' Federation Limited has stated that as instructed by the Additional Chief Secretary / Commissioner of Revenue Administration, Skimmed Milk Powder and Cattle Feed etc., was supplied by the Tamil Nadu Co-operative Milk Producers' Federation Limited on behalf of the Government of Tamil Nadu towards flood relief and has requested the Government to reimburse the amount of Rs.601.10 lakh to the Tamil Nadu Co-operative Milk Producers' Federation Limited against the supply made towards the flood relief to the Government of Kerala.
- 3. In the letter second read above, the Additional Chief Secretary/ Commissioner of Revenue Administration has recommended the proposal of the Managing Director, Tamil Nadu Co-operative Milk Producers' Federation Limited, for sanctioning a sum of Rs.6,01,10,850/- under State Funds towards supply of Skimmed Milk Powder 25 kg./ 1 kg., Cattle Feed, Mineral Mixture and Flavoured Milk - 200 ml Tetra pack to Kerala State Flood relief, based on the announcement of the Hon'ble Chief Minister.

4. In the letter third read above, the Managing Director, Tamil Nadu Co-operative Milk Producers' Federation Limited has stated that the actual quantity of Skimmed Milk Powder, Cattle Feed, Mineral Mixture and Flavoured Milk etc., was supplied at a cost of Rs.6,01,90,850 (Rupees six crore one lakh ninety thousand eight hundred and fifty only) and requested to reimburse the same to the Tamil Nadu Co-operative Milk Producers' Federation Limited for the following items supplied by the district unions.
