ORDER:

In the Government Order first read above administrative and financial sanction were accorded for a sum of Rs.4.00 crore towards rehabilitation of the residential quarters of the Dairy Development Department located at Madhavaram Milk Colony, Chennai.

- 2. In the letter second read above the Director of Milk Production and Dairy Development has stated that an amount of about Rs.90.00 lakhs is available as savings in the estimate for the work of rehabilitation of the residential quarters in Madhavaram and requested for rejuvenation of old park nearest to the administrative building of Dairy Development Department at an estimated cost of Rs.33.00 lakhs from the aforesaid savings amount.
- 3. The Director of Milk Production and Dairy Development has also stated that an old milk booth lies attached to the headquarters Office of the Commissioner of Milk Production and Dairy Development, is a glorious vestige of the past, wherein distribution of milk to the public was carried out

by the Dairy Development Department themselves to the public till 1981. (prior to the inception of aavin). Ever since the closure of the milk booth in 1981, this old milk booth building continued to function as a canteen for the benefit of the Government employees of this campus, and continued to function till 2015. This Old milk Booth building, the adjoining shed and the compound wall all got severely affected during the Chennai rain flooding Disaster of December 2015 and further battered by the Vardah cyclone of December 2016. Refurbishing this old milk booth in preserving the inherent heritage of this 60 year old campus, is absolutely necessary and this will enable the canteen to be restarted much to the benefit of the employees and the public. He has also stated that, the work of repairing the damaged milk parlour inside the Office of the Commissioner of Milk Production and Dairy Development has been completed and the Tamil Nadu Co-operative Milk Producers' Federation Limited, has furnished the estimate of the work of repair and refurbishment of the Old milk booth for Rs.3,10,000/-.

- 4. The Director of Milk Production and Dairy Development has also stated that out of Rs. 4 crore allocated for the rehabilitation of residential quarters of Dairy Development Department, so far Rs.3.10 crore has been spent and the remaining Rs.90 lakhs has been surrendered.
- 5. The Director of Milk Production and Dairy Development has therefore requested the Government to accord sanction for a sum of Rs. 33.00 lakhs for rejuvenation of old park nearest to administrative building of Dairy Development Department and to sanction a sum of Rs. 3,10,000/- for refurbishing the damaged old milk booth attached with Dairy Development Department Campus, at Madhavaram.(work already completed)
- 6. The Government after careful examination have decided to accept the proposal of Director of Milk Production and Dairy Development and accord sanction for a sum of Rs.33,00,000/- (Rupees Thirty Three Lakh only) for rejuvenation of old park and a sum of Rs.3,10,000/- (Rupees Three Lakh and Ten Thousand only) for refurbishing the damaged old milk booth at Dairy Development Department.
- 7. The expenditure sanctioned at para 6 above shall be debited to the following head of Account:-

"2404-00 Dairy Development - 001 Direction and Administration State's Expenditure .AA Establishment of Milk Production and Dairy Development Department. 18 Maintenance 02 Special maintenance

- 8. Necessary additional funds will be provided in RE/FMA 2019-2020. Pending provision of funds in RE/FMA 2019-2020, the Director of Milk Production and Dairy Development is authorized to incur the expenditure sanctioned in para 6 above. However, the above expenditure shall be brought to the note of the legislature by specific inclusion in the supplementary estimates 2019-2020. He is also requested to include the above item of expenditure sanctioned in RE/FMA 2019-2020 and also send draft explanatory note for inclusion in the supplementary estimate to the Finance (Animal Husbandry, Dairying and Fisheries) Department without fail.
- 9. The Director of Milk Production and Dairy Development is requested to furnish the utilization report for the amount sanctioned above to Government.
- 10. This order issues with the concurrence of Finance Department vide its U.O. No 43269/Animal Husbandry, Dairying and Fisheries Department/2019, dated 10.09.2019 and with ASL. No. 1419 (One thousand four hundred and nineteen)
