ORDER:

In the Government order first read above, orders were issued sanctioning a sum of Rs.62,43,45,000/- being the Government's share (both Central and State) as relief amount for disbursement of relief assistance to 2,08,115 Marine Fishermen during the fishing lean period for the year 2018-19 under the National Savings Cum Relief Scheme.

2. In the Government Order second read above, orders were issued sanctioning a sum of Rs.11,85,000/- being the Government share (both Central and State) towards the disbursement of savings cum relief amount to the newly enrolled fishermen in Thoothukudi and Tirunelveli Districts for the year 2018-19.

- 3. In the Government Order third read above, orders were issued according administrative approval for implementation of the National Savings Cum Relief Scheme for Marine Fishermen under Government's share (both Central and State) during the year 2019-20 by adopting the existing pattern of assistance and guidelines approved by Government of India and also to accord permission to the Director of Fisheries on the following:
 - i. To enroll the eligible Marine Fishermen and to collect total subscription amount of Rs.1500/- over a period of 9 months @ Rs.175/- per month for eight months and Rs.100/- in ninth month, as per the fishing months adopted in the respective districts.
 - ii. To collect the subscription amount for the first 6 months (i.e, January to June 2019) in one lumpsum pertaining to 10 districts [Viz. Tiruvallur to Ramnad (including Rameswaram)] and for 3 months (i.e April to June 2019) pertaining to Kanyakumari district as a special case. For the remaining districts (Thoothukudi and Tirunelveli) and remaining months, the subscription collection will be done as per the guidelines.
- iii. To remit the subscription amount collected from the enrolled eligible beneficiaries directly in the bank account of the respective fishermen cooperative societies or Assistant Director of Fisheries. The concerned fishermen cooperative society will reconcile the beneficiaries contribution and the number of beneficiaries within the due date for remittance and transfer the same to the respective SB Accounts maintained in the name of Director of Fisheries, Chennai in IDBI and ICICI banks through Real Time Gross Settlement (RTGS).
- iv. To adopt the comprehensive modalities framed for effective implementation of this scheme annexed to this order.
- v. To permit the coastal Assistant Directors of Fisheries to utilize the Below Poverty Line (BPL) certificate obtained from the respective District collectors for the old eligible fishermen beneficiaries and to take action to obtain necessary BPL certificates for the newly enrolled fishermen if any, who shall be included in the next year scheme i.e.2020-21.
- 4. In the letter fourth read above the Director of Fisheries has reported that in accordance with Government order coastal Assistant Director of Fisheries have been instructed to take immediate action to enroll eligible fishermen, to collect subscription amount from them and to remit the same in the respective district SB account maintained in IDBI and ICICI banks.

5. The Director of Fisheries has also reported that the non fishing period adopted in 3 different Zones are as follows:

- 8. The Director of Fisheries has requested the Government to sanction a total sum of Rs.63,58,41,000/- being the State and Central Government share for disbursement of relief amount through NEFT method to the Marine Fishermen beneficiaries towards their contribution under this scheme for the year 2019-20 and also to permit the Director of Fisheries to release the subscription amount collected from the beneficiaries along with the State share during the 3 months lean period.
- 9. The Government have examined the proposal of the Director of Fisheries at para 8 above carefully and decided to accept it. Accordingly, sanction is accorded for a sum of Rs.63,58,41,000/- (Rupees sixty three crore fifty eight lakhs forty one thousand only) being towards the State and Central Government share towards the disbursement of Savings cum Relief amount to 2,11,947 Marine Fishermen beneficiaries along with their contribution under this scheme for the year 2019-20 and also permit the Director of Fisheries to release the subscription amount collected from the beneficiaries along with the State and Central Government share during the 3 months lean period.
- 10. The Government also authorise the Director of Fisheries to draw and deposit the amount sanctioned in para 9 above in the PD/SB A/c being operated in the name of Director of Fisheries and to disburse the relief amount to the beneficiaries of coastal districts through NEFT (National Electronic Funds transfer) by utilizing the services of IDBI / ICICI bank as approved in G.O.(Ms) No.285, Animal Husbandry, Dairying and Fisheries (FS-3) Department, dated:04.11.2013.

11. The expenditure sanctioned in para 9 above shall be debited under the following head of account:-
