ORDER:

Livestock Sector plays an important and vital role in providing nutrition, income generation, employment and poverty alleviation for the rural poor. Livestock and poultry rearing is an imperative factor for improving the Indian economy and food security. The National Livestock Mission to be implemented by the Government of India intends to achieve sustainable growth and development of livestock sector including poultry, increasing the fodder production and

promoting skill development

2. The Government of India, in its letter first read above has informed that it has formulated a National Livestock Mission (NLM) to be implemented from 2014-2015 by subsuming and modifying seven Centrally Sponsored Schemes and seven Central Sector Schemes and

the National Livestock Mission is organised into the following four Sub-Missions:-

- a. Sub-Mission on Livestock Development,
- b. Sub-Mission on Pig development for the North Eastern Region,
- c. Sub-Mission on Feed and Fodder Development and
- d. Sub-Mission on Skill Development, Technology Transfer and extension.
- 3. The Government of India in their National Livestock Mission Operational Guidelines 2014-2015 at para 4.2.1 has envisaged that the respective State Government / Union Territories are required to notify the State Level Executive Committee (SLEC) under the Chairmanship of Chief Secretary, having representatives from other concerned Departments of State Government, the State Agricultural Universities (SAU), Institute under Indian Council of Agricultural Research (ICAR), Dairy Cooperatives, Farmers' / Animal Rearers' / Poultry Associations, etc, which will oversee implementation of the Mission in respective State. The Central Government will nominate its representative who will be a member in the State Level Executive Committee (SLEC). At operational level, State Governments shall constitute and notify a State Livestock Mission (SLM) which would be an empowered body for implementing the Mission Programmes at State and District Levels. The Principal Secretary / Secretary, Animal Husbandry will be the State Mission Director. He will also function as the Member Secretary of SLEC. The Director of Animal Husbandry will service the SLEC and the SLM. Panchayat Raj Institutions (PRI) existing in the State will be fully involved in implementation of the Mission, for forwarding the above proposal to Government of India for financial assistance. Further at District Level, the NLM Operational Guidelines stipulates that District Livestock Mission Committee (DLMC) will be responsible for carrying forward the objectives of the Mission for project formulation, implementation and monitoring. Accordingly, State Government / UT are required to issue necessary notification for constitution of DLMC which will be headed by the District Collector, having as members the Chief Executive Officer (CEO) of Zila Parishad or Zila Panchayat / Chief Development Officer / District Development Officer / PD of District Rural Development Agency (DRDA), representatives from concerned line Departments, Dairy Cooperatives, Farmers / Animal Rearers / Poultry Associations, Marketing Boards, Local Banks, Self Help Groups and other Non Governmental Organizations.
- 4. Consequent to the above direction by the Government of India with NLM operational guidelines, the Government after careful examination orders that a State Level Executive Committee (SLEC) be constituted to prepare and submit proposals as laid down at paras

5.1.1 and 5.1.2 of the aforesaid operational guidelines to the Mission Director, NLM, Government of India as indicated below:-

- 5. The State Level Executive Committee (SLEC) shall be responsible for
- i. Preparing proposals to be placed before the NLM of Government of India as per the operational guidelines.
- ii. Monitoring the progress of the sanctioned projects / schemes.

- iii. Reviewing the implementation of the scheme's objectives and ensure that the programmes are implemented in accordance with the guidelines laid down.
- iv. Ensuring that no duplication of efforts or resources takes place.
- v. Commissioning / undertaking field studies to monitor the implementation of the projects.
- vi. Initiating evaluation studies from time to time, as may be required.
- 6. The State Level Executive Committee (SLEC) shall meet as and when required, but shall meet atleast once in a quarter. The Committee shall be treated as First Class Committee and the Non Official Members of the Committee are eligible to Travelling Allowance / Daily Allowance as per rules in force.
- The Government also orders that the Director of Animal Husbandry and Veterinary Services shall be the estimating, controlling and implementing authority under the projects/ scheme covered in National Livestock Mission, Government of India and he is directed to prepare such proposals to place the same before the aforesaid Committee Members, obtain their approval and to forward the approved proposals along with the minutes of SLEC to the Government in Animal Husbandry, Dairying and Fisheries Department for onward transmission to the National Livestock Mission, Government of India in co-ordination with Tamil Nadu Veterinary and Animal Sciences University / Commissioner of Milk Production and Dairy Development, if need be. In respect of schemes implemented by the Tamil Nadu Co-operative Milk Producers' Federation/ Commissioner of Milk Production and Dairy Development, the Commissioner of Milk Production and Dairy Development shall take separate and similar action as stated above.
- 8. Further, the Director of Animal Husbandry and Veterinary Services is also directed to pursue with the Government of India for nominating their representative who has been included as a member in the State Level Executive Committee (SLEC). As per the above operational guidelines of National Livestock Mission, Government of India, the Director of Animal Husbandry and Veterinary Services shall service the SLEC and the SLM and the Panchayat Raj Institutions (PRI) existing in the State shall be fully involved in implementation of the Mission, for forwarding the above proposal to Government of India for financial assistance. The Director of Animal Husbandry and Veterinary Services shall carry out the responsibilities as per the operational guidelines of NLM, Government of India.

- 9. Orders with regard to constituting and notifying SLM (State Livestock Mission), DLMC (District Livestock Mission), SLSMC (State Level Sanctioning and Monitoring Committee) for operating EDEG (Entrepreneurship Development and Employment Generation) component through an EDEG Cell, headed by an Officer not below the rank of Joint Director for servicing the above SLSMC as per the aforesaid guidelines shall be issued in due course and the Director of Animal Husbandry and Veterinary Services is directed to forward such proposals to the Government at the earliest in conformity with the said guidelines.
- 10. This order is issued with the concurrence of Finance Department vide its U.O. No.39716/Fin(AH&F)/2014, dated 21.7.2014.
