ORDER:

The Hon'ble Minister (Fisheries, Personnel and Administrative Reforms) has made the following announcement on the floor of Legislative Assembly while moving the Fisheries demand (No.7) on 05.07.2019.

"தமிழ்நாடு மீனவர் நலவாரிய உறுப்பினர்களுக்கு பல்வேறு உதவித் திட்டங்களை துரிதமாக வழங்கிட நவீன நுண்ணறி அடையாள அட்டைகள் மற்றும் இணையதள சேவைகள் 50 இலட்சம் ரூபாய் செலவில் ஏற்படுத்தப்படும்" (அறிவிப்பு எண்.33)

2. In the letter read above, the Member Secretary, Tamil Nadu Fishermen Welfare Board has stated that the Tamil Nadu Fishermen Welfare Board (TNFWB) was established in 2007 with a view to ensure social security and well being of fishers and labourers engaged in fishing and its allied activities. At present a total of 4.65 lakh fishermen / fisherwomen and allied labourers are enrolled as members in the Board. In an effort to provide social security to unorganised fishermen and allied labourers in the fisheries sector, it is proposed to implement online service delivery and to issue ID cards to Tamil Nadu Fishermen Welfare Board members from both Inland and Marine sectors.

- 3. The Member Secretary, Tamil Nadu Fishermen Welfare Board has also stated that Tamil Nadu Fishermen Welfare Board will provide Computers with accessories to 31 Assistant Director of Fisheries offices all over Tamil Nadu. This arrangement provides access to respective Assistant Director of Fisheries office or application service providers to manage the services like Accident relief, Marriage, Education assistance etc., provided by Tamil Nadu Fishermen Welfare Board (TNFWB) in on time. This may prove to be a highly scalable mode of service delivery, and enable each stage of claim application processing to be viewed by applicant itself, thus ensuring the transparency in claim processing and benefit transfer. The online service provided by the Tamil Nadu Fishermen Welfare Board is mobile compatible as the site can be viewed and used even on a Smart phone provided with the valid credentials.
- 4. The Member Secretary, Tamil Nadu Fishermen Welfare Board has also stated that the issuing Smart ID Cards to the Tamil Nadu Fishermen Welfare Board members is to create unique identity number for the members of Tamil Nadu Fishermen Welfare Board throughout the state for better monitoring and service delivery of welfare assistance. This will fulfill the fundamental need of having a secure and authentic transaction in the present state e-governance environment in our State and help them avail multiple benefits related to health, insurance, pension, Accident relief, Marriage, Education assistance and banking services within the state near future.
- 5. The expenditure details for implementation of the above announcement is as follows:

The Member Secretary, Tamil Nadu Fishermen Welfare Board has stated the expenditure for the above proposal will be met from the Tamil Nadu Fishermen Welfare Board funds.

6. The Member Secretary, Tamil Nadu Fishermen Welfare Board has therefore requested the Government to issue necessary administrative approval for implementation of "Online Service Delivery of multiple benefits and for Issue of Smart ID Card" to the members of Tamil Nadu Fishermen Welfare Board at a cost of Rs.50 lakhs. The Member Secretary, Tamil Nadu Fishermen Welfare Board has stated that the expenditure for the above proposal will be met from the Tamil Nadu Fishermen Welfare Board funds.

- 7. The Government after careful examination of the proposal of the Member Secretary, Tamil Nadu Fishermen Welfare Board have decided to accept the same. Accordingly the Government accord administrative approval for implementation of Online Service Delivery of multiple benefits and for Issue of Smart ID Card to the members of Tamil Nadu Fishermen Welfare Board at a cost of Rs.50,00,000/- (Rupees Fifty lakhs only). The Expenditure for the same shall be met from the Tamil Nadu Fishermen Welfare Board funds.
- 8. The Director of Fisheries / Member Secretary, Tamil Nadu Fishermen Welfare Board is also directed to follow the Tamil Nadu Transparency in Tenders Act 1998/Rule 2000 while implementing the above scheme.
