ORDER:

In Government letter first read above, 28 proposals to the tune of Rs. 16079.63 lakh, including the proposal for supply of 200 Fiber Reinforced Plastic Boats (FRP Boats) upto 10M over all length (OAL) with engine, nets and insulated ice boxes as a replacement of traditional/wooden boats at a total cost of Rs.850.00 lakh, as approved by the State Level Approval and Monitoring Committee (SLAMC) of Government of Tamil Nadu under the "Centrally Sponsored Scheme on Blue Revolution: Integrated Development and Management of Fisheries", have been forwarded to National Fisheries Development Board for technical scrutiny and to recommend the proposals to the Central Approval and Monitoring Committee.

2. In the letter second read above, the Government of India has conveyed its approval to the following consolidated proposal of Government of Tamil Nadu for development of marine fisheries in this State at a total cost not exceeding

Rs.39.70 crore under the Centrally Sponsored Scheme on Blue Revolution: Integrated Development and Management of Fisheries during the year of 2018-2019 as follows:-

The Government of India has also released its first instalment of Rs.4,90,69,000/-for the year 2018-2019.

3. In the letter third read above, the Director of Fisheries has stated that Government of India, Ministry of Agriculture, Department of Animal Husbandry, Dairying and Fisheries has accorded administrative sanction for implementation of the scheme of supply of 200 Fiber Reinforced Plastic boats upto 10M over all length (OAL) including engine, nets and insulated ice boxes as a replacement of traditional/wooden boats under Centrally Sponsored Scheme on Blue Revolution: Integrated Development and Management of Fisheries at a total cost of Rs.850.00 lakh as detailed below:-

- 4. The Director of Fisheries has further stated that the Central Approval and Monitoring Committee (CAMC) recommended for the release of 50% of the total Central share as 1st instalment, enabling the State Government to commence the project implementation. The Director of Fisheries has also stated that the Government of India had informed that remaining Central share shall be released after fulfilling the conditions and on submission of Utilization Certificate in respect of the Central share released/utilized. Since, Government of India has released a sum of Rs.102.00 lakh being 1st instalment of Central share, matching grant of State share has to be released for implementation of the scheme for providing 200 FRP boats upto 10M OAL including engine, nets and insulated ice boxes as a replacement of traditional/wooden boats.
- 5. The Director of Fisheries has, therefore, requested the Government to accord administrative sanction for implementation of the scheme of supply of 200 FRP boats upto 10M OAL including engine, nets and insulated ice boxes as a replacement of traditional/wooden boats and to release a sum of Rs.173.06 lakh being 1st instalment of Central and State Government share including 3% of administrative expenses on admissible Central Share [Central Rs.102.00 lakh + State Rs.68.00 lakh + administrative expenses Rs.3.06 lakh] for implementation of the scheme during the year 2018-19 as detailed below:-

Total amount to be released by Government of Tamil Nadu is Rs.173.06 lakh (Rupees one crore, seventy three lakh and six thousand only)

The Director of Fisheries has further requested the Government to accord permission to implement this scheme through the Tamil Nadu State Apex Fisheries Cooperative Federation Limited (TAFCOFED).

6. Further while moving the Demand for Fisheries (No.7) on the floor of the Assembly for the year 2019-20, the Hon'ble Minister for Fisheries, Personnel and Administrative Reforms has made the following announcement:

- 7. The Government, after careful examination, have decided to accept the above proposal of the Director of Fisheries. Accordingly, Administrative Approval is accorded for implemention of the scheme of supply of 200 FRP boats upto 10M Over all length (OAL) including engine, nets and insulated ice boxes as a replacement of traditional/wooden boats at a total cost of Rs.850 lakh (Rupees Eight crore and Fifty lakh only) (unit cost Rs.4.25 lakh) under the Centrally Sponsored Scheme on Blue Revolution Integrated Development and Management of Fisheries for the year 2018-19 and financial sanction is accorded for a sum of Rs.173.06 lakh (Rupees one crore seventy three lakh and six thousand only) as first instalment for implementing the scheme. Further the Director of Fisheries is permitted to implement the scheme through the Tamil Nadu State Apex Fisheries Cooperative Federation Limited (TAFCOFED).
- 8. The amount sanctioned in para 7 above shall be debited to the following head of account:

9. Necessary additional funds will be provided in Revised Estimate /Final Modified Appropriation 2019-20. Pending provision of funds in Revised Estimate /

Final Modified Appropriation 2019-20, the Director of Fisheries is authorized to incur the expenditure sanctioned in para 7 above. He is also requested to include the above item of expenditure while sending the proposal of Revised Estimate /Final Modified Appropriation 2019-20 to the Finance (AH&F) Department without fail.

- 10. The Director of Fisheries is authorized to draw and disburse the amount sanctioned in para 7 above. The Director of Fisheries is also requested to follow the Government of India's guidelines scrupulously while implementing the scheme and to send Utilization Certificates / Physical and financial progress report to Government / Government of India.
- 11. Orders in respect of Motorization of Traditional Crafts shall be issued separately.
- 12. This order issues with the concurrence of Finance Department vide its U.O.No.22214/AH&F/2019, dated 18.06.2019 and ASL No.469 (Four hundred Sixty nine)
