ORDER:

In the Election Manifesto 2016, it has been announced that a separate housing scheme would be implemented for the fishermen.

- 2. Considering the livelihood and economic conditions of the fishermen of both marine and inland sector, the Commissioner of Fisheries has submitted the proposal for the construction of houses on sharing pattern between Central and State Governments' under Central Sector Scheme on Blue Revolution: Integrated Development and Management of Fisheries.
- 3. The proposal of the Commissioner of Fisheries has been examined carefully. Though the houses under Indira Awas Yojana (IAY) is constructed on a 25 sq.mts area, at a unit cost of Rs. 1.20 lakh per house, the Government of Tamil Nadu is implementing the above scheme at a cost of Rs.1.70 lakh per house. As the area of the fishermen house as per the guidelines of the Blue Revolution Scheme of Government of India is 25 sq.mt., the Government issue Administrative Approval to construct 5000 houses at a total cost of Rs. 85.00 crore for Fishermen both in Rural and Urban areas at a unit of Rs.1.70 lakh as in the case of Indira Awas Yojana. The Government of India contribution per house will be Rs.60,000/- and balance Rs.1.10 lakh shall be provided by the State Government. The total cost of Rs.85 crore will be initially borne by the

Government of Tamil Nadu and as and when Government of India releases its share, it will be adjusted against the Government of Tamil Nadu fund released in advance. Further, selection of beneficiaries in both rural and urban areas will be done by the Fisheries Department and the construction will be done by the Rural Development and Panchayat Raj (RD&PR) Department in all Districts.

4. The expenditure under this scheme shall be debited in the following head of account:-

"2216 Housing – 80 General – 800 Other expenditure schemes in the Twelfth Five Year Plan – VI Schemes shared between State and Centre – UA Construction of Houses for Fishermen – 09 Grants-in-Aid-03 Grants for specific schemes (DPC.2216 80 800 UA 0933)"

- 5. After the selection of beneficiaries the Commissioner of Fisheries is requested to send proposal for sanction of funds during 2016-2017 to Government.
