### ORDER:

In the letters first and third read above, the Registrar, Tamil Nadu Veterinary and Animal Sciences University has stated that in India over 70 per cent of the populations are practicing agriculture and animal husbandry for their livelihood. Livestock sector plays a pivotal role in the economy of rural India. The contribution of livestock to meet the protein requirements of the people is significant. Milk, meat and eggs are the major food items contributed by the livestock and in addition skin, wool, fiber and manure are also obtained.

2. The Registrar, Tamil Nadu Veterinary and Animal Sciences University has stated that to enhance the production and productivity of livestock and to meet the existing protein demand, several initiatives and steps are being taken up by Tamil Nadu Veterinary and Animal Sciences University in the area of Education, Research and Extension and University has metamorphosed into a nationally and globally recognized centre of

higher education in the field of veterinary and animal sciences and food sciences.

- 3. The Registrar, Tamil Nadu Veterinary and Animal Sciences University has further stated that currently, the University has six constituent colleges, out of which four are Veterinary Colleges in Tamil Nadu viz, Chennai, Namakkal, Orathanadu and Tirunelveli, one College of Food and Dairy Technology at Koduvalli, Chennai and one College of Poultry Production and Management at Hosur. The fifth Veterinary College and Research Institute at Thalaivasal in Salem district and sixth Veterinary College and Research Institute at Veerapandi Village in Theni district are under the process of commencing the admissions for BVSc & AH from the current academic year (2020-2021).
- 4. The proposal aims at establishment of Veterinary College and Research Institute at Pannaikinaru village, Udumalpet Taluk in Tiruppur District with annual admission of 80 students per year in BVSc & AH course and to start with 40 students initially. As per the proposal, the academic year will begin from 2021-22 with admission of 40 students initially which will be made 80 subsequently.
- 5. The Registrar, Tamil Nadu Veterinary and Animal Sciences University has furnished the details of the enterupon permission given by the District Collector, Tiruppur, classification of the land and photo copy of the land for establishment of the proposed Veterinary College and Research Institute with an extent of 42.89 acres of land at Pannaikinaru Village, Udumalpet Taluk, Tiruppur District.
- 6. The Registrar, Tamil Nadu Veterinary and Animal Sciences University has stated that to establish a Veterinary College and Research Institute (VC&RI) at Pannaikinaru Village, Udumalpet Taluk in Tiruppur District at a total cost of Rs. 255.87 crore has been proposed spreading over a period of five years.
- 7. Since the construction of a new building for the ensuing Veterinary College and Research Institute at Pannaikinaru Village, Udumalpet Taluk in Tiruppur District will take time as there is a due process to start the construction of buildings, the Collector, Tiruppur District has sent the proposal to commence Veterinary College and Research Institute in private buildings owned by RKR Higher Secondary School premises at P.B.No.50, Tiruppur Road, Chinnaveerampatti Village, Udumalpet Taluk in Tiruppur District from the academic year 2020-21 since the buildings has enough space for accommodating office of the Dean and administrative block, class room, laboratory, library, auditorium, staff room, canteen and space for parking of vehicles and it is very easy for the students to access for the field work. The District Collector, Tiruppur has, therefore, requested the Government to issue order to commence Veterinary College & Research

Institute in the above private building at Chinnaveerampatti Village, Udumalpet Taluk in Tiruppur District from the academic year 2020-21.

8. In this context, the Registrar, Tamil Nadu Veterinary and Animal Sciences University has stated that to start a new Veterinary College and Research Institute, necessary infrastructure have to be created for the first and second year courses along with Livestock Farm Complex and Teaching Veterinary Clinical Complex as per the Minimum Standards of Veterinary Education (MSVE-2016) and it is mandatory to get approval from the Veterinary Council of India by furnishing all the details including land related / building related information. The District Collector, Tiruppur has informed that an existing private building at R.K.R. Higher Secondary School, P.B.No.50, Tiruppur Road, Chinnaveerampatti Village, Udumalpet Taluk in Tiruppur District owned by private management, satisfy the needs of starting the new Veterinary College and Research Institute now. The following details were furnished by the Registrar, Tamil Nadu Veterinary and Animal Sciences University based on the report of the Collector, Tiruppur District.

- 9. The Registrar, Tamil Nadu Veterinary and Animal Sciences University has informed that since the infrastructure facilities in the form of existing private buildings owned by RKR Higher Secondary School premises at P.B.No.50, Tiruppur Road, Chinnaveerampatti Village, Udumalpet Taluk in Tiruppur District are available and as the minimum requirements for starting a new Veterinary College as per the requirements of MSVE 2016 could be achieved, the Veterinary College may be started in the above buildings in Tiruppur District from the current academic year 2020-21.
- 10. The Registrar, Tamil Nadu Veterinary and Animal Sciences University has therefore requested the Government to sanction Rs.255.87 crore to establish a Veterinary College and Research Institute at Pannaikinaru Village, Udumalpet Taluk in Tiruppur District from the academic year 2020-21 with an extent of 42.89 acres of land.
- 11. The Government after careful examination have decided to accept the proposal of the Registrar, Tamil Nadu Veterinary and Animal Sciences University and accord administrative sanction for a sum of Rs. 9472.68 lakh (Rupees Ninety four crore seventy two lakh and sixty eight thousand only ) (Recurring Expenditure-Rs.1074.68 lakh + Non-Recurring Expenditure-Rs.185.00 lakh and civil works Rs.8213.00 lakh) for first year along with 43 posts of Teaching Staff and 92 posts of Non-Teaching Staff (The posts of Data Entry Operator, Attendant and Driver to be filled up by outsourcing) for establishment of Veterinary College and Research Institute, at Pannaikinaru Village, Udumalpet Taluk in Tiruppur District from the academic year 2020-21.
  - i. The course to be offered is BVSc&AH with 40 students initially in the year 2020-21, and will be made 80 later.
  - ii. The University norms may be followed for the initial appointment of both teaching and non-teaching staff. In respect of non-teaching posts like the posts of Data Entry Operator, Attendant and Driver may be filled up by out sourcing at the rate of Rs.15000/- p.m. for Data Entry Operator and Driver and Rs.9000/- p.m. for Attendant including the service charges, taxes etc. The teaching and Non-Teaching posts are sanctioned as in the annexure to this order.

- iv. Out of 22 civil works, the most essential building and Road infrastructures may be allowed for the commencement of works for a total sum of Rs.8213 lakh as was done for the Veterinary College and Research Institute, Theni.
- 12. The Government also accord financial sanction for a sum of Rs.5000.00 lakh (Rupees Fifty Crore Only) for Civil Works to establish Veterinary College and Research Institute, at Pannaikinaru Village, Udumalpet Taluk in Tiruppur District for the year 2020-21 and the balance amount of Rs.3213.00 lakh for Civil Works and Rs. 1259.68 lakh (Recurring Expenditure Rs.1074.68 lakh + Non-Recurring Expenditure Rs.185.00 lakh) will be released in the subsequent financial year based on needs.
- 13. Based on the request of the Collector, Tiruppur District and the remarks of the Registrar, Tamil Nadu Veterinary and Animal Sciences University, the Tamil Nadu Veterinary and Animal Sciences University is permitted to use the private buildings owned by R.K.R. Higher Secondary School premises, P.B.No.50, Tiruppur Road, Chinnaveerampatti Village,

Udumalpet Taluk in Tiruppur District by following due procedures for one year. Once the new buildings are ready at Pannaikinaru Village, Udumalpet Taluk in Tiruppur District, the entire college will be shifted from the private building to the new buildings proposed to be constructed by the Tamil Nadu Veterinary and Animal Sciences University with the support of Public Works Department (Buildings), at Pannaikinaru Village, Udumalpet Taluk in Tiruppur District.

- 14. The Civil works for the establishment of Veterinary College and Research Institute at Pannaikinaru Village, Udumalpet Taluk in Tiruppur District will be executed by the Office of Engineer in Chief (Buildings) of Public Works Department.
- 15. The expenditure sanctioned in para 12 above shall be debited to the following new Head of Account opened under D.No.06-03:

"2415- Agricultural Research and Education – 03 – Animal Husbandry – 277 – Education – State's Expenditure – AE – Establishment of Veterinary College and Research Institute (VC&RI) at Tiruppur 309 Grants-in-Aid 03 – Grants for Specific Schemes". (IFHRMS DPC: 2415-03-277-AE-30903) (Old DPC: 2415 – 03 – 277- AE- 0938)

- 16. The Director of Animal Husbandry and Veterinary Services is the Estimating, Reconciling and Controlling authority for the above said new Heads of Account.
- 17. The Pay and Accounts Officer/ Treasury Officer concerned are directed to open the above new head of account in their books.
- 18. The expenditure sanctioned in para-12 above shall constitute an item of "New Service" and the approval of the Legislature will be obtained in due course. Pending approval of the Legislature, the expenditure may be initially met by drawal of an advance from the Contingency Fund. The Director of Animal Husbandry and Veterinary Services is directed to calculate the actual amount required for the period upto next supplementary Estimates and apply for sanction of the same as advance from the Contingency Fund to Finance (BG.I) Department directly in Form "A" appended to the Tamil Nadu Contingency Fund Rules 1963 along with a copy of this order. Orders for sanction of an advance from the Contingency Fund will be issued from Finance (BG.I) Department. The Director of Animal Husbandry and Veterinary Services is also directed to send necessary draft explanatory notes to include the above expenditure in the Supplementary Estimates for the year 2020-2021 to Government in Finance (BG-I/AHD&F) Department at the appropriate time without fail.

- 19. The Registrar, Tamil Nadu Veterinary and Animal Sciences University is directed to obtain recognition from the Veterinary Council of India, New Delhi and other mandatory clearance if any.
- 20. This order issues with the concurrence of Finance Department vide its U.O.No.26836 /Fin(AHD&F)/2020, dated.18.08.2020 and Additional Sanction Ledger No:370 (Three Hundred and Seventy).
