ORDER:

In the Government Order second read above, the Government have framed Tamil Nadu Waqf Tribunal (Conditions of Service and Procedure) Rules, 2016 and notified in the Tamil Nadu Government Gazette, dated 07.10.2016 as per sub-section (1) and clauses (xxii), (xxiia) and (xxiii) of subsection (2) of section 109 of the Waqf Act, 1995.

2. In the Government Orders 5th, 4th and 6th read above the Government have appointed Ms. A Balkis, Sessions Judge, Sessions Court for trial of cases relating to Communal clashes, Madurai as Chairman of Tamil Nadu Waqf Tribunal, Thiru.M. Mohammed Badusha, District Revenue Officer / Zonal Officer, Greater Chennai Corporation, Chennai and Thiru. S.M. Meera Mohideen, Advocate as its members of Tamil Nadu Waqf Tribunal respectively as per sub section (4) of section 83 of the Waqf Act, 1995, (Central Act 43 of 1995).

- 3. As per sub section (1) of section 83 of the Waqf Act, 1995, the State Government shall, by notification in the Official Gazette, constitute as many Tribunal as it may think fit, for the determination of any dispute, question or other matter relating to a waqf or waqf property, eviction of a tenant or determination of rights and obligations of the lessor and the lessee of such property, under this Act and define the local limits and jurisdiction of such
- 4. The Government, after careful consideration, have decided to constitute Tamil Nadu Waqf Tribunal at Chennai. Accordingly, the following Notification will be published in the Tamil Nadu Government Gazette, Extraordinary, dated 22,02.2018.
