ORDER:-

Under the Centrally Sponsored Scheme, the Government of India is providing 100% Central Assistance towards implementation of Post-Matric Scholarship Schemes for Other Backward Classes.

2. In the Government letter third read above, the proposal was sent to Government of India seeking financial assistance of Rs.129.37 Crores being 100% grant under the Government of India's Post Matric Scholarship Scheme for 2018-19 to Other Backward Classes students. In the letter first read above, the Government of India had released an amount of Rs.46,06,50,000/- (Rupees Forty Six Crore Six lakh and Fifty Thousand only) towards Central Assistance to the Government of Tamil Nadu for providing scholarships to Other Backward Class Students of hostellers and day scholars under the Centrally Sponsored Scheme of Post-Matric Scholarship for Other Backward Class students during 2018-19.

3. In the meantime, the Government of India had released an amount of Rs.15,35,50,000/- (Rupees Fifteen Crore Thirty Five lakh and Fifty Thousand only) towards Central Assistance to the Government of Tamil Nadu under the Centrally

Sponsored Scheme of Post-Matric Scholarship for Other Backward Class students for the year 2018-19.

4. The Government after careful consideration accord sanction for a sum of Rs.61,42,00,000/- (Rupees Sixty one crore and forty two lakh only) for implementation of Government of India Post-Matric Scholarship Scheme to Other Backward Class students for the year 2018-19.

5. The expenditure sanctioned in para 4 above shall be debited under the following Heads of account :-

6. The expenditure sanctioned above shall be drawn and adjusted against the expenditure already incurred by the State Government under the following heads of account towards payment of Post-Matric Scholarship.

7. The expenditure sanctioned in para 4 above shall be met out from the funds provided in Revised Estimate 2018-19 under the relevant head of account. The Director of Backward Classes Welfare and Director of Most Backward Classes and Denotified Communities shall draw and adjust the amount sanctioned in para 4 above.

8. The above Scheme shall be made applicable to Group A, B, C & D students as per norms and guidelines prescribed in the Government of India's Post-Matric Scholarship Scheme for OBCs.
