### **Order:**

In the Government order first read above, the Government have constituted a Committee to Examine the request for change of nomenclature from DNC to DNT, under the Chairmanship of Principal Secretary to Government, Revenue and Disaster Management Department, Secretariat, Chennai – 9. The Committee has been requested to submit its report to the Government within 60 days.

2) In the letter second read above, the Member-Secretary of the Committee has stated that the Committee held its first meeting on 10.12.2018 to discuss about the terms of reference and the subject matter. The committee has decided to gather more data, have a field study and analyze the same. Since more time is required for undertaking the above task, the Committee among other things has decided to request the Government for extending the term of the Committee beyond 60 days and requested the Government to extend the term of the above Committee beyond 60 days, in order to have field study and Data analysis for preparing a final report.

3) In this regard, Government after careful consideration, decided to extend the term of the Committee. Accordingly, the Government extends the tenure of the Committee to examine the request for change of nomenclature from DNC to DNT by another 30 days from 12.01.2019.

4) The Committee is requested to submit its report to the Government on the terms of reference already issued in Government Order first read above.
