ORDER:-

In the Government Orders first and second read above, orders were issued framing guidelines for Financial Assistance to repair and renovation of Christian Churches and Rs.1.00 crore was sanctioned for the scheme. Further, in Government Orders third and fourth read above, Rs.6.00 crore was sanctioned for the above Scheme.

2. In the letter fifth read above, the Director of Minorities Welfare has requested to increase the amount of grant sanctioned under the scheme citing increase in the cost of raw materials and also requested to include additional basic amenities such as construction of pedestal, construction of toilet facilities and drinking water facilities.

3. The Government, after careful consideration of the proposal of the Director of Minorities Welfare, has decided to accept the same and permit the following basic amenities for consideration for sanctioning of Grant to Churches, in addition to the repair and renovation of Churches:-

- a) Construction of pedestal in Churches
- b) Construction of Toilet facilities
- c) Creation of Drinking Water facilities

Further, in view of cost escalation in works, the amount of Grant allotted to Churches, considering the age of the building, is hereby enhanced as follows:-

- i) The amount of grant is enhanced from Rs.1.00 lakh to Rs.2.00 lakh (for 10-15 years);
- ii) The amount of grant is enhanced from Rs.2.00 lakh to Rs.4.00 lakh (for 15-20 years);
- iii) The amount of grant is enhanced from Rs.3.00 lakh to Rs.6.00 lakh (for 20 years and above).

4. This order issues with the concurrence of Finance Department vide its U.O. No.8347/ Finance (BC, MBC & MW)/2023, Dated 14.03.2023.
