



## **ABSTRACT**

Minorities Welfare – Centrally Sponsored Scheme – Pradhan Mantri Jan Vikas Karyakram (PMJVK) - 62 projects in Minority concentrated areas of ten Districts in Tamil Nadu – Administrative and Financial Sanction – Orders - Issued.

### **ORDER:-**

In the Government Order first read above, orders were issued for the implementation of Pradhan Mantri Jan Vikas Karyakram by constituting Committees at the State, District and Block level. In the same Government Order, the Government also ordered that

- a) The Directorate of Minorities Welfare would be the implementing agency for the Pradhan Mantri Jan Vikas Karyakram (PMJVK).
- b) Sanction was accorded to adopt the funding pattern of the Ministry of Minority Affairs, Government of India wherein 60% share would be from Government of India and 40% share from State Government.

2. The Ministry of Minority Affairs in its letters second and third read above, has approved 55 projects in the 33<sup>rd</sup> Empowered Committee Meeting and 7 projects in the 34th Empowered Committee Meeting at an estimated cost of Rs.615,75.41 lakh for Tamil Nadu (Central share (60%) Rs.36,949.25 lakh and State Share (40%) Rs.24,630.16 lakh) in the year 2021-2022 as follows:-

3. In the letter fourth read above, the Director of Minorities Welfare has requested to accord administrative sanction for 55 projects approved in the 33<sup>rd</sup> Empowered Committee Meeting and 7 projects approved in the 34th Empowered Committee Meeting at an estimated cost of Rs.615,75.41 lakh for Tamil Nadu (Central share (60%) Rs.36,949.25 lakh and State Share (40%) Rs.24,630.16 lakh). Further, he has requested to accord financial sanction for Rs.184,22.22 lakh being the first instalment of Government of India share and for Rs.123,15.08 lakh being the first instalment of State share towards implementation of the Centrally Sponsored Scheme of Pradhan Mantri Jan Vikas Karyakram (PMJKV) approved during the year 2021-2022 for 62 projects in Minority Concentrated areas of ten Districts in Tamil Nadu mentioned in paragraph 2 above as per the Ministry of Minority Affairs Guidelines and instructions issued thereon.

4. The Government after careful consideration, hereby accords administrative sanction for an amount of Rs.615,75,41,000/- (Rupees Six Hundred and Fifteen crore, Seventy Five lakhs and Forty One Thousand only) (Central share (60%) Rs.369,45,25,000/- and State Share (40%) Rs.246,30,16,000/-) and also accord financial sanction for an amount of Rs.184,22,22,500/- (Rupees One Hundred and Eighty Four crore, Twenty Two lakhs, Twenty Two Thousand and Five Hundred only) being the first instalment of Government of India share towards implementation of the

Centrally Sponsored Scheme of Pradhan Mantri Jan Vikas Karyakram (PMJKV) approved during the year 2021-2022 for 62 projects in Minority Concentrated areas of ten Districts in Tamil Nadu mentioned in paragraph 2 above as per the Ministry of Minority Affairs Guidelines and instructions issued thereon. Detailed list of projects and amount sanctioned are given in Annexure.

5. The amount sanctioned in paragraph 4 above shall be debited to the following head of account:

**“4225 - Capital Outlay on Welfare of Scheduled Castes, Scheduled Tribes, Other Backward Classes and Minorities - 04 - Welfare of Minorities - 102 - Economic Development - Schemes shared between State and Centre - UB - Pradhan Mantri Jan Vikas Karyakram - 416 - Major Works - 01- Major Works.”**

6. The Director of Minorities Welfare shall follow the instructions given below: -

- a) The Director of Minorities Welfare is directed to disburse the amount to the District Collectors as prescribed by the Government of India, Ministry of Minority Affairs.
- b) The Director of Minorities Welfare is instructed to monitor the implementation of the scheme.
- c) All the concerned District Collectors are instructed to implement the scheme following the Guidelines issued by the Government of India, Ministry of Minority Affairs.
- d) The remaining amount will be released later based on the progress of work.
- e) The Director of Minorities Welfare and all the concerned District Collectors are directed to furnish the status of utilization of the Central and State share in the prescribed format to Government.

7. Necessary additional funds of Rs.178,22,22,500/- will be provided in Revised Estimate/Final Modified Appropriation 2022-2023. However, this expenditure shall be brought to the notice of the Legislature by Specific inclusion in the Supplementary Estimate 2022-2023. Pending provision of such funds, the Director of Minorities Welfare and all the concerned District Collectors are directed to furnish the status of utilization of the Central and State share in the prescribed format to Government. The Director of Minorities Welfare is authorized to draw and disburse the amount sanctioned in paragraph 4 above. The Director of Minorities Welfare is also directed to include this item of expenditure while sending the proposal for Revised Estimate/Final Modified Appropriation 2022-2023 and also send necessary draft explanatory note for inclusion of this expenditure in the Supplementary

Estimate 2022-2023 to Government in Finance (BC,MBC&MW/BG-I) Department at the appropriate time without fail.

8. This order issues with the concurrence of Finance Department, vide its U.O. No.23502/Finance (BC, MBC & MW) /2022, dated 18/05/2022 with Additional Sanction Ledger No.0198 (One Hundred and Ninety Eight).
