ORDER:-

An Announcement was made by the Hon'ble Finance Minister in the Budget Speech 2023-2024 in the Tamil Nadu Legislative Assembly that the grant provided for repair and renovation of churches will be increased from Rs.6.00 crore to Rs.10.00 crore and many heritage shrines including St. George Church, Madurai, Schwartz Church, Thanjavur and Christ Church, Salem will be taken up for renovation.

- 2. The Director of Minorities Welfare in his letter second read above has stated that estimates were received from St. George Church in Madurai District for an amount of Rs.1.55 crore and requested to sanction Rs.10.00 crore for the year 2023-2024.
- 3. The Government after careful examination has decided to sanction a sum of Rs.2 Crore for the repair and renovation heritage churches. The Director of Minorities Welfare is directed to incur the expenditure of Rs.1.55 Crore from the fund sanctioned for repair and renovation of St. George Church in Madurai District for the year 2023-2024.

4. The expenditure sanctioned in paragraph 3 above shall be debited to the following head of accounts:-

"2250 - 00 - OTHER SOCIAL SERVICES - 103 - Upkeep of Shrines, Temples etc. - State's Expenditure - JA - Repairs and Renovation of Christian Churches - 309 - Grants in Aid - 03 Grants for Specific Schemes"

5. The amount sanctioned in paragraph 3 above shall not be paid in cash but shall be credited into the following head of account by means of Cheque / Demand Draft drawn in favour of Public Deposit Account of Tamil Nadu Minorities Economic Development Corporation (TAMCO):-
