### **ORDER:**

In the Government Order first read above, orders were issued sanctioning a sum of Rs.60,00,000/- as Grant to Tamil Nadu Waqf Board for the year 2019-2020 for carrying out major repairs and renovation works of 18 needy Waqf Institutions.

2. The Hon'ble Deputy Chief Minister, among others, has made the following announcement under Budget speech for the year 2020-2021:-

“மசூதிகளின் பராமரிப்புக்காக ஆண்டுதோறும் வழங்கப்படும் நிதியுதவி 60 இலட்சம் ரூபாயிலிருந்து 5 கோடி ரூபாயாக உயர்த்தி வழங்கப்படும்”.

3. The Chief Executive Officer, Tamil Nadu Waqf Board in his letters second read above has stated that the Government is sanctioning grants for Major Repairs and Renovation of Mosques and Dargahs from 1999 onwards to the needy Waqf Institutions which are in dilapidated condition and require urgent renovation work. He has therefore, requested the Government to enhance the renovation grant from Rs.60.00 Lakh to Rs.5.00 Crore from the year 2020-2021.

4. The Government after careful examination, accorded administrative sanction to enhance the Grants to Tamil Nadu Waqf Board

for Major repairs and renovation works of Mosques and Dargahs from Rs.60,00,000/- to Rs.5,00,00,000/-(Rupees Five Crore only) and the funds will be released based on requirement.

5. This order issues with the concurrence of Finance Department vide its U.O.No.15474/Fin(BC,MBC)/2020, dated 28.05.2020.
