ORDER:

In the Government Order first read above, the revised constitution of the M.S.S. Waqf Board College, Madurai has been framed for the administration of the College. In the letter second read above, the Special Officer, Tamil Nadu Waqf Board has stated that the tenure of the Governing Body of the M.S.S. Waqf Board College, Madurai expired on 09.04.2020 and the election to the Governing Body has to be conducted for every three years. He has requested the Government to consider for appointment of the Chief Executive Officer, Tamil Nadu Waqf Board as Secretary & Correspondent of the M.S.S. Waqf Board College, Madurai till a regular Secretary and Correspondent of the M.S.S. Waqf Board College, Madurai is appointed.

2. The Government have examined the request with reference to the revised constitution of the M.S.S. Waqf Board College, Madurai as there is no provision to appoint a Secretary and Correspondent other than as specified in Clause V B(2) and after careful consideration the Government have decided to amend the revised constitution of the M.S.S. Waqf Board College, Madurai issued in the Government Order first read above as follows:-

AMENDMENT

In the revised constitution of the M.S.S. Waqf Board College, Madurai, in Clause V-B under the heading "2. Secretary and Correspondent", the following sub-clause shall be added, namely:-

"(3). Whenever the Governing Body is not constituted, all the powers and duties which may, by or under the provisions of this Constitution, be exercised or performed by or on behalf of the Governing Body shall during such period, be exercised and performed by an Administrator appointed by the State Government and such person shall also function as Secretary and Correspondent of the College."


