ORDER:

As per the orders of the Hon'ble High Court of Madras first read above, the Government under Section 64 of the Tamil Nadu Vanniyakula Kshatriya Public Charitable Trusts and Endowments (Protection and Maintenance) Act, 2018 (Tamil Nadu Act No. 44 of 2018) appointed Hon'ble Thiru. Justice A. Kulasekaran (Retd.,) as Chairman of the P.T. Lee Chengalvaraya Naicker Trust and also appointed 8 other trustees to the Trust in the Government Order second read above, in consultation with the Tamil Nadu Vanniyakula Kshatriya Public Charitable Trusts and Endowments Board.

2. In the Government Order third read above, Hon'ble Thiru Justice P. Kalaiyaran (Retd.,) has been appointed as the chairman of the Trust, since Thiru Justice A. Kulasekaran (Retd.,) resigned from the post of chairman of the trust on account of his appointment as chairman of the commission for collection of quantifiable data on Castes, Communities and Tribes of Tamil Nadu.

3. The Government has been in receipt of various communications on the functioning of P.T. Lee Chengalvaraya Naicker Trust and its Members and the Government has sought clarification/report on the same from the Chairman of the Trust and the Tamil Nadu Vanniyakula Kshatriya Public Charitable Trusts and Endowments Board.

4. On detailed examination of the report of the Chairman, P.T. Lee Chengalvaraya Naicker Trust and in exercise of power under section 64 of the Tamil Nadu Vanniyakula Kshatriya Public Charitable Trusts and Endowments (Protection and Maintenance) Act, 2018 (Tamil Nadu Act No. 44 of 2018) in consultation with the Tamil Nadu Vanniyakula Kshatriya Public Charitable Trusts and Endowments Board, the Government hereby removes two Trustees viz. Thiru D. Gubendragunabalan, Trustee and Thiru N. Veerappan, Trustee from the P.T. Lee Chengalvaraya Naicker Trust.
