#### **ORDER:**

In the Government Order first read above, orders have been issued enhancing the administrative grant from Rs.2.00 Crore to Rs.2.50 Crore to Tamil Nadu Waqf Board from the year 2019-2020 onwards.

2. In the Government Order second read above, orders were issued sanctioning a sum of Rs.36,30,000/- towards payment for 11 contract posts of Junior Assistant in 11 Zonal Offices of the District Waqf Advisory Committee in the State of Tamil Nadu for the second year i.e., 2020 – 2021, to be met within the B.E 2020-2021.

3. In the Government Order third read above, orders were issued sanctioning a sum of Rs.2,13,70,000/- towards payment of administrative grant to Tamil Nadu Waqf Board for the year 2020-2021.

4. The Chief Executive Officer, Tamil Nadu Waqf Board in her letter fourth read above, has requested the Government to sanction a deficit amount of Rs.36.30 Lakh to Tamil Nadu Waqf Board towards administrative grant for the year 2020-2021.

5. The Government after careful consideration, accord sanction for a sum of Rs.36,30,000/- (Rupees Thirty Six Lakh and Thirty Thousand only) to the Tamil Nadu Waqf Board towards deficit administrative grant for the year 2020 - 2021.

6. The expenditure sanctioned in para 5 above, shall be debited under the following head of account:-

"2250-00-Other Social Services – 800 Other expenditure – State's Expenditure – AD – Other grants to Religious Institutions – Waqf Board – 309 – Grants – in – aid – 01 – Grants for current Expenditure.

7. Necessary additional funds of Rs.36,30,000/- will be provided in RBE/FMA 2021-2022. However, this expenditure shall be brought to the notice of the Legislature by Specific Inclusion in the Supplementary Estimate 2021-2022. Pending provision of such funds, the Section Officer (Bills), Backward Classes, Most Backward Classes and Minorities Welfare Department is authorized to draw and disburse the amount sanctioned in para 5 above to the Chief Executive Officer, Tamil Nadu Waqf Board, Chennai – 1 by way of NEFT. She is also directed to include this item of expenditure while sending the budget proposal for RE/FMA 2020-21 and also send necessary draft explanatory note for inclusion of this expenditure in the RBE/FMA 2021-2022 to Government in Finance (BC, MBC & MW) Department at the appropriate time without fail.

8. This order issues with the concurrence of the Finance Department vide its U.O.No.22242/Fin(BC,MBC&MW)Dept/2021, dated 15.6.2021 and ASL No.147 (One Hundred and Forty Seven).
