ORDER:

In the Government Order first read above, the Government have permitted the Tamil Nadu Co-operative Marketing Federation Limited to undertake Copra procurement under Price Support Scheme 2005. Necessary amendments were also issued in Government Orders second and third read above respectively for the proper implementation of the Scheme.

2. In the Government Order fourth read above, the Government have permitted the Tamil Nadu Co-operative Marketing Federation Limited to procure Milling Copra at the rate of Rs.51.00 per Kg and Ball Copra at the rate of Rs.53.50 per Kg under the Price Support Scheme for the year 2012 as per the guidelines/amendments issued in the Government Orders first, second and third read above.

3. In the letter fifth read above, the Registrar of Cooperative Societies has requested the Government to permit the Administrator, Tamil Nadu Co-operative Marketing Federation Limited, to procure Milling Copra for the year 2013 as per the Minimum Support Price at the rate of Rs.5250/- per quintal (Rs.52.50 per Kg) and Ball Copra at the rate of Rs.5500/- per quintal (Rs.55.00 per Kg) fixed by the Government of India as per the existing guidelines issued by the Government.

4. The Government have examined the proposal of the Registrar of Cooperative Societies and decided to accept it. Accordingly, the Administrator, Tamil Nadu Co-operative Marketing Federation Limited is permitted to procure for the year 2013 as per the Minimum Support Price of Milling Copra at the rate of Rs.5250/- per quintal (Rs.52.50 per Kg) and Ball Copra at the rate of Rs.5500/- per quintal (Rs.55.00 per Kg) fixed by the Government of India as per the existing guidelines issued in Government Orders first, second and third read above.


