ORDER:-

In Agriculture Budget 2021-2022, the Hon'ble Minister for Agriculture and Famers Welfare has made the following announcement:-

"Action will be taken to encourage value addition in minor millets and ensure remunerative price to farmers. Minor Millet rice will be procured by Co-operative Societies and distributed through Public Distribution System in Cities like Chennai and Coimbatore."

- 2. In his letter second read above, the Registrar of Cooperative Societies has sent proposals for selling Minor Millets through the select Fair Price Shops run by Cooperatives in Chennai and Coimbatore cities alongwith other Public Distribution System commodities, on pilot basis.
- 3. In this regard, a meeting was convened on 08.10.2021 to discuss on the procurement of Minor Millets, processing and value addition of the Minor Millets by the Farmers Producers Organization based on the requirement of Cooperative Department.
- 4. In his letter third read above, the Director of Agricultural Marketing and Agri Business has suggested certain modalities for procurement and selling of Minor Millets through Fair Price Shops. He has suggested that, a Committee may be organized with representative from Co-operative Department, Agriculture Department, Department of Agricultural Marketing and Agri Business, Farmer Producer Organization, Tamil Nadu Agriculture University, Department of Economics and Statistics at State Level for framing modalities to fix the price for Minor Millets.

- 5. In the circumstances stated above, the Government after careful examination, grant permission for the sale of Minor Millets in select Fair Price Shops / Retail outlets run by Cooperatives / Tamil Nadu Civil Supplies Corporation in Chennai and Coimbatore Cities alongwith other Public Distribution System commodities, on pilot basis.
- 6. Government constitute a State Level Committee, with the following members for framing modalities for processing and value addition of minor millets, pricing, etc.:-

4.	Representative from Farmer Producer Organization	Member

6.	Representative from Economics and Statistics Department	Member

The State Level Committee is directed to decide on the following:-

- i. Processing and value addition requirements.
- ii. Indent
- iii. Margin for Agricultural Marketing Societies and the margin for Cooperatives Societies / Tamil Nadu Civil Supplies Corporation.

Government also direct the District Collectors to constitute District Level Committee with the District Level Officials of concerned Departments.

- 7. The Government stipulate the following conditions for the procurement, processing and sale of Minor Millets in select Fair Price Shops / Retail outlets run by Cooperatives / Tamil Nadu Civil Supplies Corporation in Chennai and Coimbatore Cities alongwith other Public Distribution System commodities:-
 - Procurement of the Minor Millets like Ragi, Kambu, Thinai, Kuthiraivali, Saamai, Varagu etc. shall be made in select Districts through Farmers Producers Organization (FPO), promoted by Commissioner / Director of Agricultural Marketing and Agri Business.
 - 2. The processing and value addition of the Minor Millets shall also be done by the Farmers Producers Organization based on the requirement of Cooperatives / Tamil Nadu Civil Supplies Corporation. The Farmers Producers Organization shall arrange to procure, process, pack and supply Minor Millets, in sachets in their own brand name, in quantities such as 500 gram and 1kg as per the indent given by District Consumer Cooperative Wholesale Stores / Agricultural Producers Cooperative Marketing Societies / Tamil Nadu Civil Supplies Corporation. Farmer Producer Organizations shall be linked with Registrar of Co-operatives for supply of Millets in concurrence with Department of Agricultural Marketing and Agri Business and concerned District Collector.
 - 3. The Commissioner / Director of Agricultural Marketing and Agri Business shall arrange to print the MRP rates, Date of Packing, Expiry and FSSAI Certificate Number on the sachets.

- 4. Registrar of Cooperative Societies shall furnish the consolidated requirement in advance on behalf of Tamil Nadu Civil Supplies Corporation run consumer outlets and Fair Price Shops to the Commissioner / Director of Agricultural Marketing and Agri Business. The payment to the Farmers Producers Organization for the product supplied will be made by the respective Co-operative Societies / Society Retail Outlets / Tamil Nadu Civil Supplies Corporation allowing a credit period of fifteen days (15 days).
- 8. The Government also direct the District Collectors to give wide publicity among Farmer Producer Organizations and the Consumers for promotion and marketing of Millets.
