Special Public Distribution System – Extension of the scheme of Special Public Distribution System for a further period of three months from January 2022 to March 2022 – Orders issued.

### **ORDER:-**

In the G.O. first read above, the Government had introduced the scheme of distribution of Tur Dal, Urad Dal and Palmolein Oil to the family cardholders. The State Government extended the scheme periodically. From March 2017 onwards only one Dal i.e. Tur Dal / Canadian Yellow Lentil and Palmolein Oil are being supplied to the family cardholders.

2. In the G.O. second read above, the Government have extended the scheme of Special Public Distribution System for a period of six months from July 2021 to December 2021 with supply of one Dal i.e. Tur Dal / Canadian Yellow Lentil and Palmolein Oil to meet 100% requirement of the existing family cardholders. The Government also permitted the Commissioner of Civil Supplies and Consumer Protection to allot Palmolein Oil issued under Special Public Distribution System to the extent of cent percent requirement, after adjusting the Closing Stock of Palmolein Oil of the previous month, so as to cover all the eligible family cardholders for the extended period.

3. In the letter third read above, the Managing Director, Tamil Nadu Civil Supplies Corporation has stated that the implementation of the scheme of Special Public Distribution System in the State achieves its objective of controlling the prices of Dal and oil in the market, apart from safeguarding the poor and vulnerable from inflation. The Managing Director, Tamil Nadu Civil Supplies Corporation has requested orders on further continuance of the scheme of Special Public Distribution System beyond 31.12.2021.



4. In the letter fourth read above, the Commissioner of Civil Supplies and Consumer Protection has requested to extend the scheme of Special Public Distribution System for further period of one year from January 2022 to December 2022 .

5. The Government after careful examination extend the scheme of Special Public Distribution System for a period of three months i.e. from January 2022 to March 2022 with supply of one dal i.e. Tur Dal / Canadian Yellow Lentil and Palmolein Oil to meet cent percent requirement of the existing family cardholders. The Government also permit the Commissioner of Civil Supplies and Consumer Protection to allot Palmolein Oil issued under Special Public Distribution System to the extent of cent percent requirement, after adjusting the Closing Stock of Palmolein Oil of the previous month, so as to cover all the eligible family cardholders for the extended period.
