ORDER :

In the Government order first read above, orders according administrative sanction has been issued for the construction of 1166 godowns [1118 godowns for Primary Agricultural Co-operative Credit Societies and 48 godowns for Agricultural Producers Co-operative Marketing Societies] with a total storage capacity of 1,55,300 MTs at a total cost of Rs.107.26 crore with National Bank for Agriculture and Rural Development's loan assistance under Rural Infrastructure Development Fund XVII Scheme for the year 2011-2012.

2. In the Government order second read above, orders according administrative sanction have been issued for the construction of 1104 godowns [1075 godowns for Primary Agricultural Co-operative Credit Societies and 29 godowns for Agricultural

Producers Co-operative Marketing Societies] with a total storage capacity of 1,29,400 MTs at a total cost of Rs.129.76 crore with National Bank for Agriculture and Rural Development's loan assistance under Rural Infrastructure Development Fund XVIII Scheme for the year 2012-2013.

3. In the Government Order third read above, orders according administrative sanction have been issued for construction of 1044 godowns (1019 godowns for Primary Agriculture Co-operative Credit Society and 25 godowns for Agriculture Producers Co-operative Marketing Society) with a total storage capacity of 1,24,100 MTs at a total cost of Rs.140.94 crore with National Bank for Agriculture and Rural Development's loan assistance under Warehousing Infrastructure Fund Scheme for the year 2013-2014.

4. The Registrar of Co-operative Societies, in the letter fourth read above, has sent the proposal to the Government for construction of 562 godowns in Primary Agriculture Co-operative Credit Society and Agriculture Producers Co-operative Marketing Society (i.e 525 Godowns for Primary Agriculture Co-operative Credit Society and 37 Godowns for Agriculture Producers Co-operative Marketing Society) at a total estimate of Rs.109.89 crore with National Bank for Agriculture and Rural Development's loan assistance under Warehousing Infrastructure Fund Scheme for the year 2014-2015 as detailed below:-

The Registrar of Co-operative Societies has stated that Primary Agricultural Cooperative Credit Societies have not started the process of revival after getting assistance through short term Cooperative Credit structure revival package and hence without adding any more financial burden, he has proposed that the total cost of Primary Agricultural Cooperative Credit Societies godowns under this proposal be financed fully as grant. However, since Agricultural Producers Cooperative Marketing Societies can withstand commitment of 10% of the total cost of the godowns proposed under this proposal, he has stated that 10% of the cost estimate will be borne by the Agricultural Producers Cooperative Marketing Societies as under:-

The Registrar of Cooperative Societies has further stated that the creation of this additional storage space of 98,800 MT through scientific storage and produce pledge loan operation, will result in saving of 6.5% of agricultural produce stored in these Warehousing Infrastructure Fund godowns per year through reduced grain loss.

7. The Registrar of Cooperative Societies has requested the Government to accord administrative sanction for construction of **562** godowns (525 godowns for Primary Agriculture Co-operative Credit Society and 37 godowns for Agriculture Producers Co-operative Marketing Society) at a total project cost of Rs. **109,89,00,000/-** (Rupees one hundred and nine crore and eighty nine lakh only) under National Bank for Agriculture and Rural Development's Warehousing Infrastructure Fund Scheme for the year 2014-15 and to sanction **Rs. 1,07,73,10,000/-** (Rupees one hundred and seven crore, seventy three lakh and ten thousand only) as total grant for the construction of godowns which involves ;

- a) Rs.88,30,00,000/- as 100 % grant for the construction of 525 godowns for Primary Agriculture Co-operative Credit Society and
- b) Rs.19,43,10,000/- as 90% grant for the construction of 37 godowns for Agriculture Producers Co-operative Marketing Society .

8. In the letter fifth read above, the Government have forwarded the project proposal sent by the Registrar of Co-operative Societies to the Chief General Manager, National Bank for Agriculture and Rural Development for its loan assistance under Warehouse Infrastructure Fund Scheme for the year 2014-2015 as detailed below:-
