ORDER:-

In the Government Order first read above, Government have permitted the Tamil Nadu Co-operative Marketing Federation Limited to undertake Copra procurement under Price Support Scheme 2005. Necessary guidelines / amendments were also issued in that Government Order and in Government Orders second and third read above respectively for proper implementation of the Scheme.

In the Government Order 4th read above, the Government have permitted the Tamil Nadu Co-operative Marketing Federation Limited to procure Milling Copra at the rate of Rs.45.25 per Kg and Ball Copra at the rate of Rs.47.75 per Kg respectively under the Price Support Scheme for the year 2011 by following the guidelines/amendments issued in the above said Government Orders.

In the letter 5th read above, the Registrar of Co-operative Societies has requested the Government to permit the Tamil Nadu Co-operative Marketing Federation Limited, to procure Milling Copra at the rate of Rs.5100/- per quintal (Rs.51 per Kg) and Ball Copra at the rate of Rs.5350/- per quintal (Rs. 53.50 per Kg) under the Price Support Scheme for the year 2012.

The Government after careful examination, accept the proposal of the Registrar of Co-operative Societies and permit the Tamil Nadu Co-operative Marketing Federation Limited, to procure Milling Copra at the rate of Rs.5100/- per quintal (Rs.51 per Kg) and Ball Copra at the rate of Rs.5350/- per quintal (Rs.53.50 per Kg) under the Price Support Scheme for the year 2012, by following the guidelines/amendments issued in the Government Orders first, second and third read above.
