In the Government Order first read above, Government have permitted the Tamil Nadu Co-operative Marketing Federation Limited to undertake Copra procurement under Price Support Scheme 2005. Necessary guidelines / amendments were also issued in that Government Order and in Government Orders second and third read above respectively for proper implementation of the Scheme.

2. In the Government Order 4<sup>th</sup> read above, the Government have permitted the Tamil Nadu Co-operative Marketing Federation Limited to procure Milling Copra at the rate of Rs.45.25 per Kg and Ball Copra at the rate of Rs.47.75 per Kg respectively under the Price Support Scheme for the year 2011 by following the guidelines/amendments issued in the above said Government Orders.
