ORDER:

In the Government Order first read above, orders were issued revising the Dearness Allowance payable to the classes of employees in the employment in shops and commercial establishment with effect from 01.04.2013 and subsequently with effect from 10.07.2013 as per the Minimum Wages Act, 1948.

2. In the letter second read above, the Managing Director, Tamil Nadu Civil Supplies Corporation has stated that the Commissioner of Labour, Chennai has sent the statement for the revision of D.A payable to the seasonal employees with effect from 01.04.2013 and subsequently with effect from 10.07.2013 as per the Minimum Wages Act, 1948 as per Government Order first read above.

3. The Managing Director, Tamil Nadu Civil Supplies Corporation has stated that as per the orders issued in the Government order first read above, it has been proposed to implement the following revision of Dearness Allowance and Minimum wages to be implemented in Tamil Nadu Civil Supplies Corporation.

Dearness Allowance payable under the Minimum Wages Act 1948	Amount
With effect from 01.04.2013 to 09.07.2013	Rs.2129/- per month
With effect from 10.7.2013	Rs.2450/- per month
Minimum Rates of Wages payable under the Minimum Wages Act 1948 with effect from 10.7.2013 (for Zone D)	Minimum Rate of Basic Wages per Month.
Bill Clerk	Rs.2410/-
Helper	Rs.2359/-
Watchman	Rs.2359/-

The total expenditure on implementation of the above revision is Rs. 5.88 crore wherein it will be met from the food subsidy.

He has also stated that the above subject has been placed before the Board Meeting held on 29.11.2013 as item No.135 and the Board resolved to send proposal to Government for orders. Accordingly, the Managing Director, Tamil Nadu Civil Supplies Corporation, has requested orders of the Government to implement the above revision.

4. The Government after careful examination have decided to accept the proposal and accordingly permit the Managing Director, Tamil Nadu Civil Supplies Corporation, to revise Dearness Allowance and Minimum wages to the seasonal employees of Tamil Nadu Civil Supplies Corporation, as indicated below:
