ORDER:

In the Government Order 5th read above, orders have been issued for the constitution of Tamil Nadu State Food Commission by appointing Tmt.R.Vasuki, I.A.S., (Retd), Chairperson, Tmt.P.Priya Selvi, as a Woman Member as well as a Scheduled Caste Member, Thiru.M.Ganesan, Member from the Scheduled Tribe, Dr.K.Balaji Singh, Thiru.S.Asai Mani and Thiru.G.Rajamohan as other Members. The same has been notified in Tamil Nadu Government Gazette Extraordinary on 16.2.2018. Accordingly, Tmt.R.Vasuki, I.A.S.,(Retd) has assumed charge as Chairperson on 16.02.2018.

- 2. The Commissioner of Civil Supplies and Consumer Protection has requested the Government to sanction a sum of Rs.90,83,720/- (Rupees Ninety lakh eighty three thousand seven hundred and twenty only) (Rs.76,68,720 + Rs.14,15,000/-) towards both recurring and non-recurring expenses.
- 3. The Government after careful examination decided to accept the proposal of the Commissioner of Civil Supplies and Consumer Protection and sanction a sum of

Rs.89,96,920/- (Rupees Eighty Nine lakh Ninety Six thousand nine hundred and twenty only) (Rs.76,51,920 + Rs.13,45,000/-) towards both recurring and non-recurring expenses for the State Food Commission by deducting the cost of television and recurring expenditure for the first year maintenance of purchase of new car by allowing Rs.6,000/- for the second year(The details of expenditure are given in the annexure to this G.O.). The Government also sanction one post of Superintendent, Assistant, Steno Typist Grade III, Typist, Driver and Office Assistant respectively as supporting staff for the State Food Commission. The Joint Commissioner, Office of the Commissioner of Civil Supplies and Consumer Protection may take care of works pertaining to the Member-Secretary of the State Food Commission for the time being.

4. The expenditure sanctioned in Para 3 above shall be debited under the following Heads of Accounts:-

- 6. Necessary additional funds of Rs.17,75,000/- will be provided in RE/FMA 2018-2019. However, this expenditure shall be brought to the notice of the Legislature by Specific Inclusion in the Supplementary Estimate 2018-2019. Pending provision of such funds, the Commissioner of Civil Supplies and Consumer Protection is authorized to draw and disburse the amount sanctioned in para 3 above in the relevant Heads of Accounts. She is also directed to include this item of expenditure while sending the budget proposal for RE/FMA 2018-2019 and also send necessary draft explanatory note for inclusion of this expenditure in the Supplementary Estimate 2018-2019 to Government in Finance(BG.I/CF &CP) Department at the appropriate time without fail.
