APPENDIX.

NOTIFICATION.

In exercise of the powers conferred by sub-sections (1) and (2) of section 180 of the Tamil Nadu Co-operative Societies Act, 1983 (Tamil Nadu Act 30 of 1983), the Governor of Tamil Nadu hereby makes the following amendment to the Tamil Nadu Co-operative Societies Rules, 1988:-

AMENDMENT.

In the said Rules, in Schedule II, in serial number 13, under the heading "(A) Central Co-operative Banks (other than Chennai District Central Co-operative Bank, Chennai)", in item (1), for sub-items (i) and (ii), the following sub-items shall be substituted, namely:-

"(i) four members from among the Scheduled Castes and Scheduled Tribes members of the boards of affiliated societies elected by the delegates of all member societies of whom three shall be from the Primary Agricultural Credit Societies;

(ii) six members from among the women members of the boards of affiliated societies elected by the delegates of all member societies of whom four shall be from the Primary Agricultural Credit Societies;"
