Order of the Hon'ble Madurai Bench of Madras High Court in CRL.O.P (MD) Nos.9086, 10075, 10092, 10127, 11198 and 11872 of 2021, dated 13.09.2021.

ORDER:-

In the order read above, the Hon'ble Madurai Bench of Madras High Court has issued the following directions:-

- "29. When the Government is spending huge amount of money with a noble object for the supply of the rice to the needy, this Court suggests the learned State Public Prosecutor to address the Government to Constitute a committee consisting of the Commissioner of Civil Supply, the Registrar of Cooperative Societies (Distribution), the Commissioner, Tamil Nadu Civil Supply Corporation, and the Additional Director General of Police (Civil Supply CID) to suggest measures to be taken to enhance the quality of the goods supplied under the Public Distribution System and to prevent any irregularities in distribution of the same so as to achieve the very object of the scheme."
- 2. The Government after considering the above suggestion in detail have decided to constitute a committee as follows:-
 - 1. Commissioner of Civil Supplies and Consumer Chairman Protection, Chennai-5.
 - 2. Registrar of Cooperative Societies, Member Chennai-10.
 - 3. Managing Director, Member Tamil Nadu Civil Supplies Corporation, Chennai-10.
 - 4. Additional Director General of Police, Member Civil Supplies CID, Chennai-35.

3. The Government also direct the above said Committee to meet periodically and suggest measures to further enhance the quality of essential commodities being supplied in Public Distribution System and to prevent irregularities if any in the distribution of essential commodities.
