ORDER:

The Hon'ble Chief Minister of Tamil Nadu, under Rule 110 of the Tamil Nadu Legislative Assembly Rules, has made an announcement on the floor of the Legislative Assembly on 06.05.2013 for the construction of "1044 Godowns at an estimated cost of Rs.140.89 crore constructed for the benefit of the farmers".

2. In order to implement the above announcement, the Registrar of Co-operative Societies in the letter first read above, has sent the proposal to the Government for construction of 1044 Godowns (i.e., 1019 Godowns for Primary Agricultural Co-operative Credit Societies and 25 Godowns for Agricultural Producers Co-operative Marketing Societies) at a total estimated cost of Rs.140.94 crore, with National Bank for Agriculture and Rural Development's loan assistance under Rural Infrastructure Development Fund XIX scheme for the year 2013-2014, as detailed below:-

In the letter second read above, the Government have forwarded the project proposal sent by the Registrar of Co-operative Societies to the Chief General Manager, National Bank for Agriculture and Rural Development for its loan assistance under Rural Infrastructure Development Fund XIX scheme for the year 2013-2014, as detailed below:-

In the Government Order third read above, the Government have accorded administrative sanction for the construction of 1044 godowns [1019 Godowns for Primary Agricultural Co-operative Credit Societies and 25 godowns for Agricultural Producers Co-operative Marketing Societies] with a total storage capacity of 1,24,100 MTs at a total estimated cost of Rs.140.94 crore, pending National Bank for Agriculture and Rural Development's sanction.

5. In the letter fourth read above, the General Manager, National Bank for Agriculture and Rural Development, Tamil Nadu Regional office has informed that the project proposal forwarded by the Government has been sanctioned Warehouse Infrastructure Fund Ioan under National Bank for Agriculture and Rural Development Warehousing Scheme, 2013-2014 as specified below:-

6. Accordingly, in the Government Order fifth read above, the Government have accorded sanction for a sum of Rs.39,72,70,000/- (Rupees Thirty Nine crore, seventy two lakh and seventy thousand only) for the construction of 1044 Godowns as a start-up fund from the total grant of Rs.139,72,45,000/- in the Financial Year 2013-2014. Out of this,Rs.37,74,06,500/- (Rupees Thirty-seven crore, seventy four lakh Six thousand and five hundred only) is with Warehouse Infrastructure Fund loans under National Bank for Agriculture and Rural Development Warehousing Scheme, 2013-2014 and the State Government Share of Rs.1,98,63,500/- (Rupees One crore, Ninety eight lakh, Sixty three thousand and five hundred only) was involved in this project and also ordered that the balance amount will be released in the Financial year 2014-2015.

7. Now, the Registrar of Co-operative Societies, in the letter sixth read above, has stated that the amount, i.e., Rs. 39,72,70,000/- (Rupees Thirty Nine crore, seventy two lakh and seventy thousand only) sanctioned in the Government Order fifth read above, has been utilized by the Primary Agriculture Co-operative Credit Societies, and also requested the Government to release the balance amount of Rs.99,99,75,000/- for the construction of 1044 godowns in Co-operative Institutions.

8. After careful examination, the Government accord sanction for a sum of Rs.99,99,75,000/- (Rupees Ninety nine crore, ninety nine lakh and seventy five thousand only) for the construction of 1044 Godowns in Co-operative Institutions. Out of this, Rs.96,19,93,500/- (Rupees Ninety six crore, nineteen lakh, ninety three thousand and five hundred only) is with Warehouse Infrastructure Fund loans under National Bank for Agriculture and Rural Development Warehousing Scheme, 2013-2014 and the State Government Share of Rs.3,79,81,500/- (Rupees Three crore, Seventy nine lakh, Eighty one thousand and five hundred only) is involved in this project. The cost towards construction of Godowns amounting to Rs.99,99,75,000/- (Rupees Ninety nine crore, Ninety nine lakh and seventy five thousand only) is sanctioned as capital grant to the Co-operative Institutions by the Government.

9. The amount sanctioned in para 8 above shall be debited under the following head of account:-

"4425-00 Capital Outlay on Co-operation - 200 Other Investments – Schemes in the Twelfth Five Year Plan - II. State Plan - JB Construction of Godowns with loan assistance from National Bank for Agriculture and Rural Development – 16 Major Works".

10. The Financial Advisor and Chief Accounts Officer, Office of the Registrar of Co-operative Societies, Chennai is authorized to draw and disburse the amount sanctioned in para 8 above, through the Managing Director, Tamil Nadu State Apex Cooperative Bank, Chennai, to the concerned Co-operative Institutions.

11. The Registrar of Co-operative Societies is instructed to submit the project completion report in respect of each of the sanctioned projects within one month of the completion.
