ORDER:-

In the circumstances reported by the Commissioner of Civil Supplies and Consumer Protection Department in the letter fifth read above, the following amendment is issued to the G.O. (D) No. 203, Co-operation, Food and Consumer Protection (C2) Department, Dated 30.11.2018.

<u>AMENDMENT</u>

In the. G.O. (D) No. 203, Co-operation, Food and Consumer Protection (C2) Department, Dated 30.11.2018, for the existing paragraph 5(i), the following para shall be substituted:-

- 5 (i) to supply 2 litres of kerosene, in addition to 1litre usually provided for such affected families at free of cost for those families who are sheltered in the relief camps in the districts of Thanjavur, Tiruvarur, Nagapattinam and Pudukottai at free of cost.
- 2. As per the Government of India, Ministry of Petroleum and Natural Gas in its letter in the sixth read above, the 1680 KL. of kerosene has been released as an advance release under Public Distribution System for January, February, March 2019. It is also ordered that the out of 1680 KL of kerosene allotted by the

Government of India, after utilizing 336 KL. for free supply for those families who are sheltered in the relief camps in the districts of Thanjavur, Tiruvarur, Nagapattinam and Pudukottai, the balance quantity of 1344 KL will be used in regular Public Distribution System.

3. This order issues with the concurrence of the Finance department vide its U.O. No. 348/Finance (CF&CP)/2019, Dated 21.01.2019.
