ORDER:

The recent cyclonic storm “GAJA” has caused extensive damage of infrastructure, trees, crops in thousands of hectares, lakhs of huts and houses besides loss of lives in various districts of the Tamil Nadu State like Nagapattinam, Tiruvarur, Thanjavur, Pudukottai etc. The relief and rehabilitation works in the storm affected districts are being carried out on a war footing basis.

2. The Tamil Nadu Indian Forest Service Association in the representation read above, has expressed their willingness to contribute One day's salary from the members towards the relief and rehabilitation measures in the storm affected districts in the State of Tamil Nadu.

3. The Government have decided to accept the request of the Tamil Nadu Indian Forest Service Association and direct that the voluntary contributions of One day's salary shall be deducted from the salary bill of the IFS Officers for the month of January 2019 towards the relief and rehabilitation measures in the cyclonic storm “GAJA” affected districts of Tamil Nadu.

4. Accordingly, the Drawing and Disbursing Officers shall be instructed to make use of the provisions in the Web Pay role application in the calculation of one day salary in the January 2019 pay bill. The amount shall be deducted on the basis of the gross amount of salary for the month of January 2019. The amount of voluntary contribution to be recovered from the salary of Indian Forest Service Officers of Tamil Nadu Cadre through the audit officers concerned would be credited directly to the Chief Minister's Public Relief fund, Savings Bank account by Electronic clearing System (ECS) to the designated saving Bank Account of CMPRF to Indian Overseas Bank, Secretariat Branch, Chennai 600 009 {SB A/c No. 117201000000070 IFS Code IOBA0001172, CMPRF PAN: AAAGC0038F} on the due date of salary.

5. The DDOs shall inform the Government and the Commissionerate of Treasuries and Accounts, Chennai on the ECS mode of deduction from the monthly pay bill and the amount credited to the CMPRF account of the State along with the list of Officers of IFS (TN Cadre) from whom the contributions are deducted.

6. The amount deducted from the officers serving in PSUs / Corporations / Autonomous bodies on their own mode of payment of salary, shall also be credited directly to the CMPRF account of the State by ECS mode under intimation to Government.

7. This order issues with the concurrence of Finance Department vide its U.O.No.5152/ACS(F)/P/2018, dated 31.12.2018.


