ORDER:

Forestry has evolved significantly over the last few years with advent of several new technologies. There is a paradigm shift in forest management practices. Modern day forestry requires thoughtful strategies to protect forest heritage for years to come. Modern forest practices should be focused on sustainable forestry practices to support forests which are invaluable resources providing oxygen for breathing, habitats for flora & fauna and livelihood opportunities for millions of people who depend on them.

- 2. Forests across the world are facing unprecedented challenges mainly due to forest degradation, climate change, invasion of alien species and increasing biotic pressure, etc. With an increase in human population and commercialization, forests are facing threats and over exploitation. In these circumstances, the importance of better forest management using newer technologies cannot be underestimated. It is in this context that the Government of Tamil Nadu has decided to modernize its forest force taking into account sustainable economic, social and ecological development requirements.
- 3. Tamil Nadu has become a leading state in wildlife conservation due to its pioneering efforts in the arena of wildlife conservation and climate change initiatives.

Government of Tamil Nadu has undertaken the following initiatives encompassing protection, conservation and promotion of biodiversity.

- 4. Government of Tamil Nadu has also launched the following three missions viz.

Green Tamil Nadu Mission

The Government of Tamil Nadu proposes to increase the Forest and Tree Cover in the State from the present 23.8% (as per the India State of Forest Report 2019 of the Forest Survey of India, Dehradun) to 33% by the year 2030-2031.

Tamil Nadu Climate Change Mission

The Government has announced the Tamil Nadu Climate Change Mission with the objective of taking ambitious and effective steps to mitigate & adapt actions through the climate lens with definite strategies, co-ordination with line departments, research evidence and well-planned measures for maximum efficiency. The primary aim of the Mission is to prepare a holistic Climate Change Policy for the Government of Tamil Nadu.

Tamil Nadu Wetlands Mission

With an increase in human population there is increasing demand in exploitation of natural resources. Whenever there is an over exploitation, it has led to degradation and fragmentation of natural habitats leading to frequent human wildlife conflicts. There is clearly a shift from earlier practices of co-existence to conflict. These conflicts hinder the conservation efforts in the field due to their negative impact as a result of crop damage, loss of human life, injuries and loss of crop. These can be devastating for the local community. It is in this context that there is a need to manage the human wildlife conflict in a scientific and professional manner. Use of modern satellite technologies, tracking of wildlife movement and unmanned aerial vehicles, use of drones, GPS enabled technologies, radio collaring and several other new innovations must be used to prevent and mitigate the impact of human wildlife conflict. Tamil Nadu forest Department therefore needs to be equipped adequately to minimize conflict situations with the use of modern technology.

- 5. Forest fires pose a serious threat to valuable forest resources. Forest fire also impacts tribal and other communities living in fringe areas often leading to loss of livelihood. Due to increasing incidents of fire under the impact of climate change, it has become critical to empower the department with necessary resources and trained manpower to prevent forest fires or minimize the loss. Several modern tools and technologies have been unveiled which are effective and low cost for better forest fire management. Government of Tamil Nadu has decided to build capacities of its staff and provide resources for better management of forest fires. Capacity building and training of forest force with newer management skills and tools is critical to enable the department to manage its forest resources better. Towards this it has become imperative to orient and train forest officers and staff on modern scientific conservation and management tools.
- 6. In today's time forestry management has undergone a complete change and has gone beyond the limits of management of forests alone. Today sustainable forest management practices must include equitable development of tribal communities which are completely dependent upon forests. Modern forest management practices must focus on integrated and participatory approaches involving several stakeholders in the sustainable growth. Environment, Climate Change & Forests Department therefore has proposed training programmes to bring transformational changes. The department is also proposing collaborative research with Social Forestry Research Institute, Advanced Institute of Wildlife Conservation etc. for better forest management practices. New forestry research will help the Department in bringing out data analysis and information which can be used by frontline forest staff to protect our natural resources.
- 7. Considering the above, during the Revised Budget Estimates 2021-2022 placed on 03.09.2021, the Government have announced on the floor of Tamil Nadu Legislative Assembly, as below:

"Special attention will be paid to the modernization of the forest force by equipping them with modern equipment and technology including Unmanned Aerial Vehicles (UAV), artificial intelligence, GIS and MIS based management systems, updated weaponry and forest worthy vehicles."

- 8. In accordance with the above announcement, Government have decided to modernise Tamil Nadu Forest Force by equipping them with modern equipments and technology, trainings and capacity building etc., with the following strategic objectives
 - a. Upgrade and adapt to modern technologies and scientific forest management practices for sustainable growth of forest resources.
 - b. Build an efficient and effective department, with well trained and skilled staff.
 - c. Implement modern strategic and operational changes to enable better protection and management of biodiversity and ecosystems.
 - d. Strengthen the service delivery infrastructure through regional facilities.
 - e. Ensure continuous updating of knowledge of forest personnel to improve the efficiency, service delivery and enhance accountability and transparency.
 - f. Improve the capability and mobility of field staff to handle Human wildlife conflict issues.
- 9. The Principal Chief Conservator of Forests has sent a proposal in this regard. The Government after careful examination, have decided to accord administrative sanction for a sum of Rs.5283.00 lakhs (Rupees Five thousand two hundred and eighty-three lakhs only) for implementing the scheme of Modernization of Tamil Nadu Forest Force for years 2022-2025 and financial sanction a sum of Rs.2211.28 lakhs (Rupees Two thousand two hundred and eleven lakhs and twenty eight thousand only) for implementation of the scheme for 2022-2023, as per the details provided in the table below:
