ORDER:

In the letter first read above, NABARD has sanctioned a loan of Rs.3738.86 Lakhs under Rural Infrastructure Development Fund IX for System Improvement in Power Sector in Tuticorin, Tirunelveli and Karur Electricity Distribution Circles of Tamil Nadu.

2. In the G.O second read above, the Government released a sum of Rs.74.778 lakhs towards startup advance out of the loan sanctioned amount of Rs.3738.86 Lakhs under Rural Infrastructure Development Fund IX for System Improvement in Power Sector in Tuticorin, Tirunelveli and Karur Electricity Distribution Circles of Tamil Nadu.

3. In the G.O. third read above, the Government released a sum of Rs.351.905 lakhs towards reimbursement claims sent out of the loan sanctioned amount of Rs.3738.86 Lakhs under Rural Infrastructure Development Fund IX for System Improvement in Power Sector in Tuticorin, Tirunelveli and Karur Electricity Distribution Circles of Tamil Nadu.

In the G.O. fourth read above, the Government released a sum of Rs.1944.428 lakhs towards reimbursement claims sent out of the loan sanctioned amount of Rs.3738.86 Lakhs under Rural Infrastructure Development Fund IX for System Improvement in Power Sector in Tuticorin, Tirunelveli and Karur Electricity Distribution Circles of Tamil Nadu.

5.. In the G.O. fifth read above, the Government released a sum of Rs.451.577 lakhs towards reimbursement claims sent out of the loan sanctioned amount of Rs.3738.86 Lakhs under Rural Infrastructure Development Fund IX for System Improvement in Power Sector in Tuticorin, Tirunelveli and Karur Electricity Distribution Circles of Tamil Nadu.

6. The Member (Accounts) / Tamil Nadu Electricity Board in the reference 6th cited, has requested to release a sum of Rs. 417.011 Lakhs towards reimbursement claims sent to NABARD out of the sanctioned loan of Rs.3738.86 lakhs to the Tamil Nadu Electricity Board for Power System Improvement in Subtransmission and distribution net work in Rural Districts viz., Tuticorin, Tirunelveli and Karur Electricity Distribution Circles.

7. The Government after careful examination, sanction and release a sum of Rs. 4,17,01,100/- (Rupees four crores seventeen lakhs one thousand one hundred only) as loan to the Tamil Nadu Electricity Board, out of loan assistance of Rs.3738.86 Lakhs from NABARD, with the terms and conditions, as stipulated in the sanction order of the NABARD in its letter first read above and as indicated in the Annexure to this order.

8.The loan sanctioned in Paragraph 7 above shall be debited to the following head of account :-

"6801.00 Loans for Power Projects – 800. Other Loans to Electricity Boards – I Non- Plan –AE. Loans to Tamil Nadu Electricity Board for implementation of System Improvement in Power Sector with Ioan assistance from NABARD under Rural Infrastructure Development Fund 01. Loans to Tamil Nadu Electricity Board.

9. The interest on the above loan shall be credited to the following head of account:-

"0049 Interest Receipts – 04 Interest Receipts of State/Union Territory Governments 190 – Interest from Public Sector and Other Undertakings. AC Loans to Tamil Nadu Electricity Board in Cash. (DPC 0049-04-190-AC-0006)

10.The loan amount of Rs.4,17,01,100/- sanctioned at para 7 above shall be adjusted against the interest amount due from the Tamil Nadu Electricity Board to the State Government for various schemes, such as, APDRP, PMGY etc and shall not be paid in cash, but credited to the following head of account:-

"0049 – Interest Receipts –04 Interest Receipts of State/ Union Territory Governments – 190 Interest from Public Sector and, Other Undertakings – AC –Loans to Tamil Nadu Electricity Board In cash".

(DPC-0049 –04 –190 –AC –0006) by means of a cheque drawn in favour of " PD Account of Tamil Nadu Electricity Board".

The Chief Electrical Inspector to Government is authorized to draw the cheque for the amount sanctioned in para-7 above for making adjustments as indicated in para 10 above to Tamil Nadu Electricity Board and to watch the recovery of Principal and Interest as per the terms and conditions of NABARD and as indicated in the Annexure to this order.
