Hon'ble Chief Minister in the election manifesto, 2016, among others, has promised provision of free electricity of 100 units bimonthly to all domestic consumers in all slabs in the existing assessment system. The Chairman cum Managing Director, Tamil Nadu Generation and Distribution Corporation Limited in the letter second cited, has sent proposal for implementation of the above scheme and for issue of letter of commitment under section 108 of Electricity Act 2003.

2) In the Government Order 3rd cited orders have been issued for provision of free electricity of 100 units bimonthly to all domestic

consumers in all slabs. The Government also issue a commitment letter under section 65 of Electricity Act 2003, for provision of additional tariff subsidy to the Tamil Nadu Generation and Distribution Corporation Limited as mentioned in the annexure to this letter in order to compensate the revenue shortfall due to the above policy direction.

- 3) The Tamil Nadu Electricity Regulatory Commission is requested to take necessary follow up action, accordingly.
