APPENDIX.

NOTIFICATION – I.

In exercise of the powers conferred by section 4 of the Tamil Nadu Forest Act, 1882 (Tamil Nadu Act V of 1882), the Governor of Tamil Nadu hereby declares that it is proposed to constitute the land within the boundaries specified in the Schedule below as reserved forest and appoints the Special Tahsildar (Forest Settlement), Dindigul ex-officio to be the Forest Settlement Officer to exercise the powers under clause (c) of the said section in respect of that land.

THE SCHEDULE.

BOUNDARIES.

North.- The boundary starts from the tri-junction point of Survey Numbers 229, 225 and 224 of No.56, Komberipatti village and generally runs towards northeast, southeast, northeast, north and east along the southern boundary of Survey Numbers 225, 70 and southern and eastern boundary of Survey Number 71 and southern boundary of Survey Number 73 of No.56, Komberipatti village and reaches the tri-junction point of Survey Numbers 73, 90 and 224 of No.56, Komberipatti village.

East.-Thence, the boundary generally runs towards southeast and south along the southwestern boundary of Survey Numbers 90, 91, 92, 93, 155 and western boundary of Survey Number 155 of No.56, Komberipatti village and reaches the tri-junction point of Survey Numbers 155, 223 and 224 of No.56, Komberipatti village.

South.-Thence, the boundary generally runs towards west and southwest along the north and southwestern boundary of Survey Number 223 of No.56, Komberipatti village and thence it runs generally towards northwest along the northern boundary of Survey Number 245 and northeastern boundary of Survey Numbers 244, 243, and 235 and reaches the tri-junction point of Survey Numbers 234, 233 and 224 of No.56, Komberipatti Village.

West.-Thence the boundary generally runs towards northwest, northeast, north, west and north along the northeastern, southeastern, eastern, northern and eastern boundary of Survey Numbers 234, 233, 232, 230 and 229 of No.56, Komberipatti village and reaches the starting point.

NOTIFICATION – II.

In exercise of the powers conferred by the last paragraph of section 4 of the Tamil Nadu Forest Act, 1882 (Tamil Nadu Act V of 1882), the Governor of Tamil Nadu hereby appoints the District Forest Officer, Dindigul Division, ex-officio, to attend on behalf of the Government at the inquiry prescribed under Chapter-II of the said Act, in respect of forest block of Komberipatti Forest Block-I proposed to be constituted as reserved forest.

NOTIFICATION – III.

In exercise of the powers conferred by the section 14 of the Tamil Nadu Forest Act, 1882 (Tamil Nadu Act V of 1882), the Governor of Tamil Nadu hereby appoints the Personal Assistant (General) to the Collector of Dindigul District, Dindigul ex-officio to hear appeals, if any, against the orders passed under sections 11, 12 and 13 of the said Act, in respect of the land of Komberipatti Forest Block –I, proposed to be constituted as reserved forest.
