**APPENDIX.**  
**NOTIFICATION – I.**

In exercise of the powers conferred by section 4 of the Tamil Nadu Forest Act, 1882 (Tamil Nadu Act V of 1882), the Governor of Tamil Nadu hereby declares that it is proposed to constitute the land within the boundaries specified in the schedule below as reserved forest and appoints the Special Tahsildar (Forest Settlement), Dindigul ex-officio, to be the Forest Settlement Officer to exercise the powers under clause (c) of the said section in respect of the said land.

**THE SCHEDULE.**

**BOUNDARIES.**

**North.**- The boundary starts from the tri-junction point of Survey Numbers 579, 561 and 535/1 of No.56 Veriyappur village runs generally towards northeast and southeast along the southern boundary of Survey Numbers 561, 535/2, 560, 559, 553, 551, 550, 539, 537, 536 and 493 of No.56, Veriyappur village and reaches the junction point of Survey Numbers 493, 533, 535/3 and 535/1 of No.56 Veriyappur village.

**East.**- Thence, the boundary generally runs towards southwest along the northwestern boundary of Survey Number 535/3 of No.56 Veriyappur village and thence runs towards southwest and south along the common village boundary of No.98, Kethaiyurampu village and No.56, Veriyppur village (at Survey Number 535/1) and reaches the trijunction point of No.98 Kethaiyurampu village, Survey Numbers 607 and 535/1 of No.56 Veriyappur village.

**South.**- Thence, the boundary generally runs towards west along the northern boundary of Survey Numbers 607, 606, 605 and 604 of No.56, Veriyappur village and reaches the trijunction point of Survey Numbers 603, 604 and 535/1 of No.56 Veriyappur village.

**West.**- Thence, the boundary generally runs towards north along the eastern boundary of Survey Numbers 603, 602, 600, 586, 585, 584, 583, 582, 580 and 579 of No.56 Veriyappur village and it reaches the starting point.

**NOTIFICATION – II.**

In exercise of the powers conferred by the last paragraph of section 4 of the Tamil Nadu Forest Act, 1882 (Tamil Nadu Act V of 1882), the Governor of Tamil Nadu

hereby appoints the District Forest Officer, Dindigul Forest Division, Dindigul ex-officio to attend on behalf of the Government at the inquiry prescribed under Chapter-II of the said Act, in respect of the land of Veriyappur Forest Block proposed to be constituted as reserved forest.

**NOTIFICATION – III.**

In exercise of the powers conferred by the section 14 of the Tamil Nadu Forest Act, 1882 (Tamil Nadu Act V of 1882), the Governor of Tamil Nadu hereby appoints the Personal Assistant (General) to the Collector of Dindigul District, Dindigul ex-Officio to hear appeals, if any, against the orders passed under sections 11, 12 and 13 of the said Act, in respect of the land of Veriyappur Forest Block proposed to be constituted as reserved forest.
