### APPENDIX.

### NOTIFICATION.

In exercise of the powers conferred by section 16 of the Tamil Nadu Forest Act, 1882 (Tamil Nadu Act V of 1882), the Governor of Tamil Nadu hereby declares that the area, the boundaries of which are specified in the Scheduled below, as reserved forest with effect on and from 07.02.2024.

### THE SCHEDULE.

### **BOUNDARIES.**

North.- The boundary starts from the trijunction of Survey Numbers 1, 2 and 3/1 of No.16, Alagapuri Village and the boundary runs towards East and South along the southern and western side of Survey Number 2 of No.16, Alagapuri Village till it reaches the north east corner of Survey Number 3/2 of No.16, Alagapuri Village. Thence it runs West, South and East along the northern, western and southern sides of Survey Number 3/2 of No.16, Alagapuri Village till it reaches the trijunction point of Survey Numbers 3/1, 3/2 and 40 of No.16, Alagapuri Village.

<u>East.</u>- Thence, the boundary generally runs towards south, east and south along the western, southern and western sides of Survey number 40 of No.16, Alagapuri Village and runs towards West and South along the northern and western sides of Survey Number 37 of No.16, Alagapuri Village till it reaches the trijunction point of Survey Numbers 37, 4 and 3/1 of No.16, Alagapuri Village.

<u>South.</u>- Thence, the boundary runs towards west along the northern side of Survey Numbers 4 and 3/3 of No.16, Alagapuri Village till it reaches the trijunction point of Survey Numbers 3/3, 3/1 and 1 of 16, Alagapuri Village.

<u>West</u>.- Thence, the boundary runs towards North along the eastern side of Survey Number 1 of No.16, Alagapuri Village till it reaches the starting point.
