### NOTIFICATION.

In exercise of the powers conferred by section 16 of the Tamil Nadu Forest Act, 1882 (Tamil Nadu Act V of 1882), the Governor of Tamil Nadu hereby declares that the area, the boundaries of which are specified in the Scheduled below, as reserved forest with effect on and from 07.02.2024.

### **BOUNDARIES.**

North.- The boundary of the forest block starts from the tri-junction point of Survey Numbers 364/1, 364/2 and 363 of Number 2, Sendhurai Village and it generally runs towards east along the southern side of Survey Number 364/1 and it reaches the tri-junction point of Survey Numbers 364/1, 355 and 364/2 of Number 2, Sendhurai Village.

<u>East</u>.- Thence, the boundary generally runs towards south along the western side of Survey Number 355 and it reaches the junction point of Survey Numbers 364/2 and 355 of Number 2, Sendhurai Village.

<u>South</u>.- Thence, the boundary generally runs towards south west along the northern side of Survey Number 355 of Number 2, Sendhurai Village and it reaches the tri-junction point of Survey Numbers 364/2, 355 and 363 of Number 2, Sendhurai Village.

<u>West</u>.- Thence, the boundary generally runs towards north along the eastern side of Survey Number 363 of Number 2, Sendhurai Village and it reaches the starting point.
