<u>APPENDIX.</u> NOTIFICATION – I.

In exercise of the powers conferred by section 4 of the Tamil Nadu Forest Act, 1882 (Tamil Nadu Act V of 1882), the Governor of Tamil Nadu hereby declares that it is proposed to constitute the land within the boundaries specified in the Schedule below as reserved forest and appoints the Special Tahsildar (Forest Settlement), Dindigul ex-officio to be the Forest Settlement Officer to exercise the powers under clause (c) of the said section in respect of that land.

BOUNDARIES.

North.- The boundary starts from the tri-junction point of Survey Numbers.116,115 and 125/1 of No.7 Adukkam village and generally runs towards Northeast, southeast and east along the southeast boundary of Survey Numbers.116, southwest and southern boundary of Survey Number.117 of No.7 Adukkam village. Thence, it generally runs towards southeast, south, east and north along the southwestern, western, southern and eastern boundary of Survey Numbers.123 and 124 of No.7 Adukkam village and thence it runs towards northeast along the southwest boundary of Survey Numbers.122 and 121 of No.7 Adukkam village and reaches the tri-junction point of Survey Numbers.121 and 125/1 of No.7 Adukkam village and No.9 Pannaikadu village.

<u>East.</u>- Thence, the boundary generally runs towards south along the common village boundary of No.9 Pannaikadu village and No.7 Adukkam village (at Survey Number.125/1) and thence generally runs towards west and south along the northern and western boundary of Survey Numbers 150,149 and 148 of No.7 Adukkam village. Thence, it generally runs towards northwest, west, south and southeast along the northeastern and northern boundary of Survey Numbers 129, 128, 127 and 126 and western boundary of Survey Numbers 126, 133, 134, 135 and northwestern and southeastern boundary of Survey Number.136 and southern boundary of Survey Number.137 of No.7 Adukkam village and reaches the junction point of Survey Numbers 137,138, 340 and 125/1 of No.7 Adukkam village.

<u>South.-</u> Thence, the boundary generally runs towards west, northwest, southeast, southwest and south along the northern and northeastern boundary of Survey Numbers 340, 399, 342, 341 and 343 and northwestern and western boundary of Survey Numbers.344, 345 and 346 of No.7 Adukkam village and thence it runs towards

northwest, southwest, northwest, west, southeast, southwest and west along the northern and western boundary of Survey Numbers 355, 358, 359, 357, 362, 361, 364 and 365 of No.7, Adukkam village and reaches the tri-junction point of Survey Numbers 365, 757 and 125/13 of No.7, Adukkam Village.

West.- Thence, the boundary generally runs towards north and northwest along the eastern boundary of Survey Numbers 757 and 102 of No.7 Adukkam village and thence runs towards east and northwest along the eastern and northeastern boundary of Survey Numbers 102 and 103 of No.7 Adukkam village. Thence it runs towards northeast along the southwestern boundary of Survey No.100 of No.7 Adukkam village. Thence the boundary runs towards southeast, east and north along the Adukkam Reserved Forest boundary and thence it runs generally towards northeast, northwest, north and northeast along the eastern, northeastern, eastern and southeastern boundary of Survey Numbers 100, 104, 105, 106, 107, 110,111,112 and 115 of No.7, Adukkam village and reaches the starting point.

Enclosures: The Patta and Government lands in Survey Numbers 125/2, 125/3, 125/4, 125/5, 125/6, 125/7, 125/8, 125/9, 125/10, 125/11, 125/12 and 125/14 of No.7, Adukkam village are situated in 13 locations within the block are free from notification and be an enclosures. The approach path for the enclosures will be dealt during the settlement process.

NOTIFICATION - II.

In exercise of the powers conferred by the last paragraph of section 4 of the Tamil Nadu Forest Act, 1882 (Tamil Nadu Act V of 1882), the Governor of Tamil Nadu hereby appoints the District Forest Officer and Wildlife Warden, Kodaikanal Wildlife Sanctuary, Kodaikanal, ex-officio, to attend on behalf of the Government at the inquiry prescribed under Chapter-II of the said Act, in respect of forest block of Adukkam Forest Block-III proposed to be constituted as reserved forest.

NOTIFICATION - III.

In exercise of the powers conferred by the section 14 of the Tamil Nadu Forest Act, 1882 (Tamil Nadu Act V of 1882), the Governor of Tamil Nadu hereby appoints the Personal Assistant (General) to the Collector of Dindigul District, Dindigul ex-officio to hear appeals, if any, from the orders passed under sections 11, 12 and 13 of the said Act, in respect of the land of forest block of Adukkam Forest Block-III proposed to be constituted as reserved forest.
