ORDER:

In the Notification first read above, the Government of India allotted the following six Indian Forest Service officers to Tamil Nadu Cadre:-

Subsequently, the above said six officers had undergone training at the Indira Gandhi National Forest Academy, Dehradun during the year 2020 – 2022.

2. In the letter second read above, the Indira Gandhi National Forest Academy, Dehradun had sent the bills for a sum of Rs.1,13,05,307/- (Rupees One Crore thirteen lakh five thousand three hundred and seven only) incurred by the Academy, pertaining to pay and allowances, training expenses, Travelling Allowances, Leave Travel Concession and Medical bills, National Pension Scheme amount paid during the training imparted to the six Indian Forest Service Probationers while they had undergone training at Indira Gandhi National Forest Academy, Dehradun, during their training from 2020 to 2022, for sanction.

3. The Principal Chief Conservator of Forests in the letter third read above, has requested to sanction a sum of Rs.1,13,05,307/- (Rupees One Crore thirteen lakh five thousand three hundred and seven only) incurred by the Indira Gandhi National Forest Academy, Dehradun, towards the training expenses of the above said six Indian Forest Service Probationers of 2020 Batch of Tamil Nadu Cadre, during their training period at Indira Gandhi National Forest Academy, Dehradun, and the said amount may be drawn and sent to the said Academy through E-Payment.

4. The Government, after careful examination of the proposal of the Principal Chief Conservator of Forests, hereby sanction a sum of **Rs.1,13,05,307/- (Rupees One crore thirteen lakh five thousand three hundred and seven only)**, towards reimbursement to the Indira Gandhi National Forest Academy, Dehradun, being the expenditure incurred for training imparted to the above said six Indian Forest Service Probationers in connection with their salary / tour programmes etc., during their training period from 2020 to 2022.

5. The expenditure sanctioned in para 4 above shall be debited to the following Head of Account:-

2406 – Forestry and Wildlife – 01. Forestry – 001 – Direction and Administration – State’s Expenditure – AB District Establishment - 372 Training- 01 Training.”

6. Necessary additional funds of Rs.1,13,05,307/- will be provided in FMA 2023-2024. Pending provision of such funds, the Deputy Conservator of Forests (Budget), Office of the Principal Chief Conservator of Forests, Chennai-32 is authorized to draw and disburse the amount sanctioned in para 4 above, to the Director, Indira Gandhi National Forest Academy, Dehradun, through E-Payment, on the Union Bank of India, Dehradun. However, this expenditure should be brought to the notice of the Legislature by Specific Inclusion in the Supplementary Estimates 2023-2024. The Principal

Chief Conservator of Forests (Head of Forest Force), Chennai-32 is directed to include the above expenditure while sending the budget proposal for FMA 2023-2024 and also send draft explanatory notes for inclusion of this expenditure in the Supplementary Estimates 2023-2024 to the Government in Finance (ECC&F/B.G-I) Department without fail.

7. The Principal Chief Conservator of Forests (Head of Forest Force), Chennai-32 is directed to send a report to Government in this regard.
