NOTIFICATION.

In exercise of the powers conferred by Section 16 of the Tamil Nadu Forest Act, 1882 (Tamil Nadu Act V of 1882), the Governor of Tamil Nadu hereby declares that the area, the boundaries of which are specified in the Schedule below, as reserved forest with effect on and from 31.07.2023.

BOUNDARIES.

North.- The boundary of the Forest Block starts from the junction point of Survey Numbers 84/1A and 84/1B of No.30, Oddanchatram Village, it generally runs towards East along the Southern boundary of Survey Number 84/1A and reaches the tri-junction point of Survey Numbers 84/1A, 84/1B of No.30, Oddanchatram Village and western side of northern slope reserved forest boundary.

<u>East.-</u> Thence, the boundary generally runs towards south along the Western boundary of northern slope reserved forest and reaches the junction point of Survey Number 84/1B of No.30, Oddanchatram Village and northern slope reserved forest.

<u>South.</u> Thence, the boundary runs towards West along the Northern boundary of northern slope reserved forest and reaches the tri-junction point of Survey Numbers 84/1A and 84/1B of No.30, Oddanchatram Village and northern slope reserved Forest.

<u>West.-</u> Thence, the boundary runs towards North along the eastern side of Survey Number 84/1A of No.30, Oddanchatram village and reaches the starting point.
