## ORDER:

In Government Order 1st read above, orders have been issued sanctioning a sum of Rs.21.00 crore for raising and planting of 47 lakh seedlings in 2021-2022 and Rs.17.80 crore for planting during 2022-2023. The source of funding to meet the above expenditure for successful implementation of Green Tamil Nadu Mission during the financial years 2021-2022 and 2022-2023 are detailed below: -

<sup>2.</sup> In the letter second read above, Government have conveyed authorization for a sum of Rs.6.39 crore towards administrative expenses to be incurred in 2022-2026 and permitted the Additional Principal Chief Conservator of Forests & Mission Director to utilize the said expenditure from the concerned savings bank account for the effective implementation of the Green Tamil Nadu Mission.

3. In the letter fourth read above, the Additional Principal Chief Conservator of Forests and Mission Director, Green Tamil Nadu Mission has furnished Utilization Certificates for Rs.24.17 crore utilized from Tamil Nadu Pollution Control Board and Rs.5.00 crore utilized from Tamil Nadu Forest Plantation Corporation Limited for the purpose of raising advance nurseries during 2022-2023. He has also furnished the break up details of additional fund of Rs.50.117 Crore required to achieve the planting target for 2022-2023.

- 4. The Additional Principal Chief Conservator of Forests and Mission Director, Green Tamil Nadu Mission has therefore requested the Government to sanction a sum of Rs.50.117 crore for planting during 2022-2023 from the funds of Tamil Nadu Pollution Control Board, as per the Tamil Nadu Pollution Control Board's Resolution No.288-4-11 dated. 17.10.2022.
- 5. After careful examination of the proposal of the Additional Principal Chief Conservator of Forest and Mission Director, Green Tamil Nadu Mission, the Government accord sanction for Rs.50,12,00,000/- (Rupees Fifty Crore and Twelve Lakh only) towards planting works during the year 2022-2023 from Tamil Nadu Pollution Control Board fund. Based on the Utilization Certificate and work progress necessary fund shall be released as approved.
- 6. The Tamil Nadu Pollution Control Board is permitted to release the funds to carryout Green Tamil Nadu Mission planting activities during 2022-2023.
- 7. This order issues with the concurrence of Finance Department vide its U.O. No.578/ADS(GKT)/2022, dated 20.12.2022.
