**North.-** Starting from the junction of No.41, Melagudalur Village Survey Numbers 2193, 2194/1A, 2194/1B, 2195 and Suranganar Reserved Forest boundary and the boundary runs generally towards east along the southern side Survey Numbers 2194/1A, 2194/2A till it reaches the north east corner of Survey Number 2194/2B and junction of Survey Numbers 2194/2B, 2194/2A and 2195 of No.41, Melagudalur Village.

**East.-**Thence, the boundary runs generally towards south along the northern boundary of Survey Number 2195 till it reaches the south east corner of Survey Number 2194/2B of No.41, Melagudalur village.

**South and West.-**Thence, the boundary runs generally towards west along the northern boundary of Survey Number 2195 till it reaches the starting point and junction of No.41, Melagudalur Village Survey Numbers 2193, 2194/1A, 2194/1B, 2195 and Suranganar Reserved boundary.
