NOTIFICATION.

In exercise of the powers conferred by section 16 of the Tamil Nadu Forest Act 1882 (Tamil Nadu Act V of 1882), the Governor of Tamil Nadu hereby declares that the area, the boundaries of which are specified in the Schedule below, as reserved forest with effect from 13.09.2023.

THE SCHEDULE.

BOUNDARIES.

North.- Starting from the North-western corner of Survey Number 63 of Number 3, Pallapatty Village junction with Survey Number 64 of the said village and Survey Number 119 of Number 9, Pottapatty Village and generally runs towards East along the southern boundary of Survey Number 119 of Number 9, Pottapatty Village till it reaches the north-eastern corner of Survey Number 63 of Number 3, Pallapatty Village which is also the quadra-junction of Survey Numbers 51, 63 and 59 of Number 3, Pallapatty Village and Survey Number 119 of Number 9, Pottapatty Village.

<u>East.-</u> Thence, the boundary runs generally towards South-west along the western sides of Survey Numbers 51 and 62 of Number 3, Pallapatty Village, till it reaches the quadruplicate junction of Survey Numbers 62, 96, 65 and 63 of the said Village.

<u>South.</u>- Thence, the boundary turns towards West and runs along the northern boundary of Survey Number 65 of Number 3, Pallapatty Village till it reaches the tri-junction point of Survey Numbers 65, 64 and 63 of No. 3, Pallapatty Village.

<u>West.-</u> Thence, the boundary runs generally towards North along the eastern side of Survey Number 64 of No. 3, Pallapatty Village and reaches the starting point.
