APPENDIX. NOTIFICATION.

In exercise of the powers conferred by section 16 of the Tamil Nadu Forest Act 1882 (Tamil Nadu Act V of 1882), the Governor of Tamil Nadu hereby declares that the area, the boundaries of which are specified in the Schedule below, as reserved forest with effect from 13.09.2023.

THE SCHEDULE.

BOUNDARIES.

North.- The boundary of the forest block starts from the tri-junction point of Survey Numbers 64/1 and 64/2 of Number 18, Kuttam Village and Karumalai reserved forest. Thence, it generally runs towards east along the southern side of Survey Number 64/2 and it reaches the junction point of Survey Numbers 64/1 and 64/2 of Number 18, Kuttam Village.

<u>East</u>.- Thence, the boundary runs generally towards south along the western side of Survey Number 64/2 and it reaches the tri-junction point of Survey Numbers 64/1, 64/2 and 1002 of No.18, Kuttam Village.

<u>South</u>.- Thence, the boundary generally runs towards west along the Northern side of Survey Number 1002 of No.18, Kuttam Village and it reaches the tri-junction point of Survey Numbers 1002 and 64/1 of No.18, Kuttam Village and Karumalai reserved forest.

<u>West</u>.- Thence, the boundary generally runs towards north along the eastern boundary of Karumalai reserved forest and it reaches the starting point.
