APPENDIX. NOTIFICATION.

In exercise of the powers conferred by Section 16 of the Tamil Nadu Forest Act 1882 (Tamil Nadu Act V of 1882), the Governor of Tamil Nadu hereby declares that the area, the boundaries of which are specified in the Schedule below, as reserved forest with effect from 20.09.2023.

BOUNDARIES.

No.62, Melappidavur Village and Survey Number 226 of No.92, Mallal Village and the boundary generally runs towards Northeast along the southeastern boundary of Survey Numbers 226 and 225 of No.92, Mallal Village and reaches the tri-junction point of Survey Number 264 of No.62, Melappidavur Village, Survey Number 225 of No.92, Mallal Village and Survey Number 263 of No.96, Sembanur Village. Thence, the boundary generally runs towards east along the southern boundary of Survey Numbers 263, 264, 265, 269, 270, 271, 272 and 273 of No.96, Sembanur Village and reaches the tri-junction point of Survey Number 264 of 62 Melappidavur Village, Survey Numbers 273 and 2 of No.96, Sembanur Village.

<u>East.-</u> Thence, the boundary generally runs towards south along the western boundary of Survey Number 2 of No.96, Sembanur Village and it reaches the tri-junction point of Survey Numbers 264 and 302 of No.62, Melappidavur Village and Survey Number 2 of No.96, Sembanur Village.

<u>South.</u>- Thence, the boundary generally runs towards west along the northern boundary of Survey Number 302 of No.62, Melappidavur Village and it reaches the junction point of Survey Numbers 277, 264, 302 and 295 of No.62, Melappidavur Village. Thence it generally runs towards North-west, south-west and west along the eastern, northeastern, northwestern and northern boundary of Survey Numbers 277 of No.62, Melappidavur Village and reaches the junction point of Survey Numbers 231, 264, 277 and 232 of No.62, Melappidavur Village. Thence it generally runs towards

northwest along the northern boundary of Survey Numbers 231 and 230 of No.62, Melappidavur Village, and it reaches the tri-junction point of Survey Numbers 226, 264 and 230 of No.62, Melappidavur Village.

<u>West.-</u> Thence, the boundary generally runs towards north along the eastern boundary of Survey Numbers 226 and 225 of No.62, Melappidavur Village and reaches the starting point.

Admitted Rights:-

The follwoing three rights are allowed with in this forest block.

RIGHTS NO.1: Channel 1

Right is admitted to the Public Works Department and Rural Development Department to use the Channel which carries the rainwater through the Forest Block and reaches the Pukkuli Tank. The Channel starts from the eastern boundary of the Melappidavur Forest Block at 190.00 mtr from south-west corner of Survey Number 264 of No.62, Melappidavur Village and runs towards southwest and reaches the western boundary of Pukkuli Tank. The Public Works Department and Rural Development Department are admitted to carry out repair and maintenance works with prior written permission of the District Forest Officer, Sivagangai. The channel is allowed to a Total Length of 460.83 Metre to a width of 8.00 Metres and the Magnetic Bearing and Distance are as follows:-

RIGHTS NO. 2: Channel 2

Right is admitted to the Public Works Department and Rural Development Department to use the Channel which carries the rainwater through the Forest Block and reaches the Pukkuli Tank. The Channel starts at 30.00 m from northeast corner of Survey Number 264 of the Melappidavur Forest Block and runs towards southwest and reaches north-eastern boundary of Pukkuli Tank. The Public Works Department and Rural Development Department are admitted to carryout repair and maintenance works with prior written permission from the District Forest Officer, Sivagangai. The Channel is allowed to a Total Length of 472.62 metre to an width of 8.00 metre and the magnetic Bearing and Distance are as follows:-
