#### **ORDER:-**

The Principal Chief Conservator of Forests and Chief Wildlife Warden in his letter third read above, has requested to sanction an amount of Rs.1067.11 lakh for payment of compensation in cases of Human-Wildlife Conflict during the year 2024-2025 and also to grant permission to utilize the previous year balance amount Rs 34.53 lakh available in SNA account for the purpose of making payment of compensation during 2024-2025.

2. The Government after detailed examination, accepts the proposal of the Principal Chief Conservator of Forests and Chief Wildlife Warden and sanction an amount of Rs.1067.11 lakh for the payment of compensation in cases of Human-Wildlife Conflict during the year 2024-2025 which shall be debited into the following head of account:-

“2406 Forestry and Wildlife – 01 Forestry – 001 Direction and Administration – I Non-Plan – AB District Establishment – 351 Compensation – 02 Other Compensations”  
(IFHRMS Code No. 2406-01-001-AB-35102)

The Government also accord permission to utilize the previous year balance amount Rs 34.53 lakhs available in SNA account for the purpose of making payment of compensation during 2024-2025.

3. The Principal Chief Conservator of Forests and Chief Wildlife Warden shall ensure that every case / proposal of compensation for loss of crops/damage to property by wild animals has to be scrutinized properly by an officer of the Forest Department not below the rank of District Forest Officer. He / She is authorized to draw and disburse the amount sanctioned in para 2 above.

4. This order does not require the concurrence of Finance Department vide its G.O.(Ms.)No.334,Finance (BG.I) Department, dated 22.10.2022.
