- 3. In the Government letter fourth read above, orders have been issued while sanctioning the Special Pay ordered in the Government Order second read above that, the Special Pay may be sanctioned to only such employees who were hitherto drawing the same and shall not be introduced anew.
- 4. In the Budget Session the Government of Tamil Nadu has made an announcement during the Assembly session 2021-22 that the pay for 212 staff of TamilNadu Tea Plantation Corporation Limited will be revised during this year towards implementation of long pending pay revision.
