ORDER:

In the Government Order first and second read above, the Government have issued orders for the implementation of the Integrated Financial and Human Resource Management System (IF&HRMS) Project, which envisages integration of both Financial and Human Resource Management. As the System contemplates end to end solution for all financial activities, various rules, procedure for drawing payments from Treasuries are being inbuilt in the system. The objective of this Project is to remove various systemic deficiencies in the manual legacy system of operation and optimizing efficiency through comprehensive business process re-engineering.

2) Accordingly, the Commissionerate of Treasuries and Accounts has proposed certain amendments to Treasury Rule 16 under Subsidiary Rule 13 and the Government accepts the amendments proposed by the Commissionerate of Treasuries and Accounts.

NOTIFICATION

In exercise of the powers conferred by Article 283 (2) of the Constitution of India, the Governor of Tamil Nadu hereby makes the following amendments to the Rules for the Tamil Nadu Treasury Code, Volume-I, in Subsidiary Rule 13 under Treasury Rule 16.

The amendments hereby made shall be deemed to have come into force on the 10th January, 2019.

AMENDMENT

In the said Tamil Nadu Treasury Code, Volume-I, in Note under Subsidiary Rule 13 of Treasury Rule 16 the following shall be added:-

"Consequent on the implementation of Integrated Financial and Human Resource Management System, provision of automation of increments to the Government servants is available in the software. In the software, list of all eligible Government servants whose increments are due in a particular quarter will be revealed, among them ineligible persons list who are not eligible for sanction of increments due to EOL without Medical Certificate (MC), stoppage of increment, non-passing of prescribed tests, non-declaration of probation etc., will also be revealed. In the system, the names of ineligible persons will be removed and automation of increments to eligible Governments servants in an office shall be enabled and sanctioned at stretch. A list of persons for sanction of increments to those who are initially ineligible and who became subsequently eligible for increment on any subsequent date shall be watched and sanctioned in system in due course".

[Note: Entries will be updated in e- Service Register (e-SR) of the Government Servants and simultaneously the payroll will also be updated.]
